
WYOMING STATE EPIDEMIOLOGICAL OUTCOMES WORKGROUP

COUNTY AND STATE HIGHLIGHTS

- For the 2009 to 2013 combined-year average, relative to other counties, Carbon County experienced the fifth highest arrest rate for drug abuse violations (719 vs. a statewide rate of 559 per 100,000 population).
- For the 2008 to 2012 combined-year average, Carbon County 10th and 12th graders ranked third highest in the state for the percentage of students reporting using an OTC medication to get high on more than one occasion in the past 30 days.
- When compared to the national arrest rate in 2012, youth in Wyoming are approximately 3.5 times more likely to be arrested for a drug abuse violation (565 vs. 145 respectively).

30-DAY MARIJUANA USE (YOUTH)


Definition: The percentage of Wyoming students who reported using marijuana on one or more occasions during the past 30 days.

DRUG ABUSE VIOLATION ARRESTS (ADULTS)





30-DAY COCAINE USE (YOUTH)


Definition: The percentage of Wyoming students who reported using cocaine on one or more occasions during the past 30 days.

SOCIAL NORMS: 30-DAY ILLICIT (ILLEGAL) DRUG USE


Definition: The percentage of Wyoming students who believe that most students in their school have used illegal drugs on one or more occasions during the past 30 days.

30-DAY PRESCRIPTION DRUG ABUSE (YOUTH)


Definition: The percentage of Wyoming students reporting using a prescription medication to get high on one or more occasions during the past 30 days.
