Certification Extension Request

State Certification Extension Request Information

Occasionally programs or providers may need to request an extension for state certification. Examples of this situation typically include coordination with a national accreditation organization (e.g. Commission on Accreditation of Rehabilitation Facilities or the Joint Commission) surrounding on-site survey and subsequent reporting time frames, or a situation in which timely submission of a renewal application has been interrupted due to unforeseen circumstances (subject to Division approval). To request an extension, the provider will submit a written request, via email is acceptable, to the Certification Program Manager. The request must state the reason for the extension request and to what date an extension request is desired. Requests for extension of certification are subject to Division review and approval.

Screening and Assessment

Wyoming Rules and Regulations for Substance Abuse Standards and NAADAC Code of Ethics

Per Wyoming Rules and Regulations for Substance Abuse Standards, Chapter 4, Section 6 (b), "Assessments can only be completed by a qualified clinical staff person who is credentialed through the Wyoming Mental Health Professions Licensing Board established under the provisions of W.S. § 33-38-101, et seq., a psychologist who is licensed to practice psychology, pursuant to W.S. § 33-27-113(a)(v), a Licensed Physician by the Wyoming State Board of Medicine, and a Wyoming Advanced Psychiatric Nurse." NAADAC: The Association for Addiction Professionals, Code of Ethics, Principle V-7 (2016, p. 13), states, "Addiction Professionals shall provide proper diagnosis of mental health and substance use disorders, within their scope and licensure. Assessment techniques used to determine client placement for care shall be carefully selected and appropriately used."
