## **2017 ACIP Recommended Vaccine Schedules Released** Kristy Westfall, VFC Coordinator

On February 7, the Centers for Disease Control and Prevention (CDC) published Advisory Committee on Immunization Practices (ACIP) Recommended Immunization Schedule for Children and Adolescents Aged 18 Years or Younger-United States, 2017 and Advisory Committee on Immunization Practices Recommended Immunization Schedule for Adults Aged 19 Years or Older-United States, 2017 as an MMWR Early Release.

Each year, the ACIP updates the immunization schedules to reflect current recommendations for licensed vaccines. In October 2016, ACIP approved the recommended immunization schedules for 2017.

If you don't provide influenza vaccination in your clinic, please recommend vaccination to your patients and refer them to a local clinic or pharmacy that provides influenza vaccine. ## Updated Vaccine Information Statement (VIS) for Gardasil-9 LaChel May, Compliance Specialist

As of December 2, 2016, Centers for Disease Control and Prevention (CDC) has released an updated Gardasil-9 Vaccine Information Statement (VIS) which contains information about the recently approved 2-dose schedule. While this updated VIS should ideally begin to be used now, existing stocks of the current VIS may continue to be used, particularly for patients using the 3-dose schedule.

\*Note: the VIS no longer specifies "Gardasil-9." This is because Gardasil-9 will soon be the only HPV vaccine available in the U.S., as Cervarix and Gardasil (quadrivalent HPV vaccine) will no longer be sold in the United States. The appropriate VIS should continue to be used for those two vaccines as long as unexpired doses remain available.

### **Public Vaccine Programs**

**2016-17 Public Influenza Vaccine Update** Kristy Westfall, VFC Coordinator

Since the 2016-17 Flu Season began, 11,340 doses of VFC influenza vaccine have been ordered. That's a lot of vaccine - but, Flu Season isn't over yet! In fact, there are many people who have still not received their annual flu shot. We did receive additional doses of influenza vaccine and all of the presentations are still available for ordering.

Because we are only guaranteed a certain number of doses of influenza vaccine each year though, it is important that providers start planning which ages still need a flu shot in your facility. Providers that see patients over the age of four (4) should plan to order doses of the Afluria and Fluvirin vaccine in order to have enough doses of the 36+ months presentations available for that age group. Otherwise, we could run out of the presentation available for the 36+ months to four (4) years age range.

\*Age indication per package insert is ≥5 years; however, ACIP recommends that Afluria not be used in children aged 6 months through 8 years because of increased risk for febrile reactions noted in this age group with Seqirus' 2010 Southern Hemisphere IIV3. If no other age-appropriate, licensed inactivated seasonal influenza vaccine is available for a child aged 5 through 8 years who has a medical condition that increases the child's risk for influenza complications, Afluria can be used; however, providers should discuss with the parents or caregivers the benefits and risks of influenza vaccination with Afluria before administering this vaccine. Afluria may be used in persons aged ≥9 years.

## Reminder for Temperature Logs Aundrea Moore, Provider Support Specialist

Temperature Logs are vital in making sure that vaccines stay viable and they are a great tool to help with maintaining your facilities compliance. As a reminder, Temperature Logs should be faxed to 307-777-2913 or emailed to wdh-vfcreporting@ wyo.gov and they are due for review by the 5th of each month. While I encourage each facility to maintain their



private stock vaccines, I do ask that the private stock Temperature Logs not be sent in to me for review. Additionally, unless requested by the Vaccine Program, please do not send in Temperature Logs for units that are not currently being used to store vaccine. If for any reason your office will be closed, please note the closure dates on your Temperature Log. We appreciate your dedication in maintaining and managing your publicly supplied vaccines at your facility.

The revised version of the *Vaccine Restitution Policy* for the replacement of publicly-supplied vaccine went into effect on January 1, 2017. No major updates to the policy were made; the changes were made to ensure the content was clear and concise. Overall, the situations in which replacement of publicly-supplied vaccine would be required did not change, only the language of the policy itself.

# Birth Order-What's the Big Deal? Jennifer Gray, WylR Interoperability Specialist

When the thought of birth order comes to mind, it's hard to see the importance of it in everyday life. So what's the big deal? When would birth

order matter? Birth order matters when it comes to HL7 messaging and Immunization Information Systems (IIS), which here in Wyoming is the WyIR. The WyIR is built on a set of functional standards that are regulated and mandated by the CDC. One of those functionalities is built around birth order. The birth order of a patient allows the system to identify a singular or multiple birth. This matters because without the birth order the WyIR will identify two patients with the similar demographic information, such as date of birth, location of birth, last name, and deem these two patients as a duplicate. Once the WyIR thinks it has identified a duplicate patient, the WyIR merges these two patients automatically. This happens with almost every twin or triplet along with patients born on the same day, in the same facility, and share similar demographic information - unless steps are taken to prevent the automatic merging. The merging of patients becomes problematic because when a facility tries to look up a patient that was merged by the system, the facility will encounter an issue. Issues, such as but not limited to: the patient missing altogether in the WyIR, the appearance of missing vaccines, or the appearance of vaccines listed on the patient record that were not administered to that patient.

### Locked out of the WyIR?

Since we are now going into the New Year, there are many users that are reporting they have been locked out of the WylR. This is typically because they have not logged into the WylR for 30 days or longer. At the end of December, 12% of all users were locked out. We would like to work on bringing this percentage down, with users logging into the WylR more often.



Once a month, per our HIPAA compliance standards, we run a monthly report for user activity. Anyone who has not logged into the WylR for 30 days or longer is set as inactive. When the user goes to enter their username and password, they will not be able to log in. This report is run around the middle of each month.

It is recommended that you disconnect your autocomplete, so that a password will not automatically populate, this can be a cause of being locked out of the WylR. The Password Management Guide will give you the steps on how to disable autocomplete.
