The following list is a summary of proposed waiver changes, to be effective July 1, 2018 or upon CMS approval, whichever is later.

Proposed Changes

- 1) Implement rate methodology developed by Navigant Consulting, Inc. and presented in the SFY 2019 Provider Rate Study (<https://health.wyo.gov/behavioralhealth/dd/bhd-public-notice/>). Proposed rates can be found in the table below.
- 2) Revise Transportation Services definition to reflect a per trip unit, with a 5 mile or 10 mile option.
- 3) Increase Supports Waiver individual cost limit to \$15,457 for participants' ages 0-20 to account for new rate methodology and corresponding rates.
- 4) Increase Supports Waiver individual cost limit to \$18,521 for participants' ages 21+ to account for new rate methodology and corresponding rates.
