Nebraska Regional Poison Center

The Nebraska Regional Poison Center (NRPC) is committed to providing the highest quality of service for the citizens of Wyoming. It is certified as a regional poison center by the American Association of Poison Control Centers. NRPC and its programs are sponsored through collaborative support from the Wyoming Department of Health Office of Emergency Medical Services, The Nebraska Medical Center, University of Nebraska Medical Center, and the U.S. Department of Health and Human Services.

This report highlights services provided to Wyoming, the medical cost savings associated with the use of NRPC, quality improvement activities, and Wyoming's 2011 poisoning statistics.

24-Hour Emergency Telephone Service

The Nebraska Regional Poison Center operates an emergency telephone service 24 hours a day, seven days a week. It is staffed by a nationally-certified team of registered nurses and physicians, whose primary function is to assess and make treatment recommendations during possible poisonings. This service is available to both health care professionals and to the public. A medical toxicologist is always available to provide toxicology consultations as needed.

The following is a summary of Wyoming calls handled by NRPC in 2011:

- Handled 8,218 total calls in 2011
- 5660 calls were regarding human and animal poisoning exposures
- 2558 calls were for poison or drug information
- 6,631 follow-up calls were made by NRPC staff
- 57% of the poisoning exposures involved children less than 6 years of age
- 83% of poisoning exposures were unintentional; 14% were intentional; 2% were the result of an adverse reaction to a drug or food; and 1% due to contamination, tampering or malicious intent
- Commonly ingested items included medications, cosmetics/personal care products, household cleaning products, foreign bodies, and pesticides
- 71% of poisoning exposures were treated safely at home
- Medical toxicologists provided consultations with Wyoming healthcare providers on the treatment of 154 poisoned patients

Wyoming Public Education

Poison Center public education activities are organized by the education coordinator, Joan McVoy RN, CSPI. Each activity is designed to inform the public about the 24-hour emergency telephone service and to provide education on methods to prevent poisonings. The following is a summary of 2011 activities in Wyoming.

Educational Materials: The Poison Center distributed 41,254 poison prevention brochures, telephone stickers, magnets, and other educational materials throughout Wyoming. Pinky the Elephant (mascot costume) was used during 40 presentations. A poison prevention program was done in every county of Wyoming.

Videotape Loan Library: The Poison Center maintains a lending library of audio-visual programs for all age groups. In 2011, a total of 8,680 people in Wyoming viewed the programs. The following table represents a breakdown of program usage:

Community Partners:

The University of Wyoming School of Pharmacy students gave 7 presentations in the Laramie area to an audience of 275.

Phyllis Lewis, University Extension Educator at the University of Wyoming in Worland, provided 32 presentations to an audience of 1,681 students in the counties of Washakie, Hot Springs, Big Horn and Park.

Suzie Delger RN, FNP, Nursing Coordinator, provided materials and information to the 74 school nurses across the state.

Wyoming Visit:

Joan McVoy, NRPC's education coordinator, visited Wyoming from September 19-September 27, 2011. Joan's presentations and meetings are summarized below.

- Visited the hospital emergency departments in Cheyenne, Laramie, Casper, Rawlins, Rock Springs and Jackson. She spoke with hospital staff and asked for feedback on NRPC's service. Poison prevention outreach materials were provided to each hospital.
- Met with instructors and pharmacy students at the University of Wyoming, School of Pharmacy. She conducted a training session for the pharmacy students on teaching poison prevention to children. The pharmacy students present poison prevention programs in Laramie elementary schools.

- The following presentations were provided in schools:
 - 2 presentations to a total of 120 students at Henderson Elementary in Cheyenne.
 - 3 presentations to a total of 137 students at Walnut Elementary in Rock Springs.
 - 1 presentation to 69 students at Overland Elementary in Rock Springs.
 - 1 presentation to 200 students at Jackson Elementary in Jackson.

- Distributed poison center brochures and magnets to several Wyoming pharmacies.

- Provided television interviews at:
 - KTWO in Casper
 - KCWY in Casper
 - KGWN in Cheyenne

Web Site: The Poison Center's web site is continuously updated with educational materials. The address is www.nebraskapoinson.com.

National Poison Prevention Week: Congress intended this event as a means for local communities to raise awareness of the dangers of accidental poisoning. In 2011, the Poison Center participated in the following activities:

- Public service announcements, radio, and newspaper interviews
- All childcare providers in Wyoming were sent postcards informing them of the poison center services and materials that are available to them.
- Proclamation by the Governor was signed for Poison Prevention Week.

Media Interviews: The Poison Center regularly sends public service announcements on poison topics to media throughout Wyoming. This generates radio and television interviews and newspaper articles. The subjects varied throughout the year: Poison prevention, carbon monoxide, spring cleaning, K2, summer hazards, boozy bears, study drugs, Halloween hazards, holiday hazards, turkey tips.

Poisoning Data Collection

The Nebraska Regional Poison Center submits all of Wyoming's poisoning data to the American Association of Poison Control Centers. This data is used both nationally and locally to target poison prevention efforts, to improve poisoning treatment, and to identify poisoning trends.

Professional Education

The Nebraska Regional Poison Center contributes regularly to health care professionals' knowledge in the area of clinical toxicology. The medical director writes periodic clinical toxicology updates for emergency department staff. These are faxed to all Wyoming hospital emergency departments and posted on NRPC's web site.

Hazardous Material Incidents/Terrorism

The Nebraska Regional Poison Center assists first responders, hospitals, and the public during hazardous material incidents. The center also assists with planning and response for chemical, biological, radiological, and nuclear (CBRN) incidents by:

- ◆ Providing immediate CBRN treatment information to health care professionals and the public on a 24-hour basis
 - NRPC staff have received specialized training on CBRN agents
 - NRPC houses an extensive reference library on CBRN agents
- ◆ Providing educational presentations to health care professionals on recognition and management of CBRN agents
- ◆ Assisting the Wyoming Department of Health with surveillance
- ◆ Tracking pharmaceutical capabilities in Wyoming and assisting in the transfer of antidotes between hospitals

An Estimate of Medical Cost Savings From Poison Center Services

The Nebraska Regional Poison Center reduces medical costs associated with treatment of poisoning by decreasing the inappropriate use of emergency departments and by preventing poisoning case progression through early intervention. In addition, NRPC reduces costs by preventing poisonings.

The following shows how NRPC reduced the cost of poisonings in Wyoming in 2011:

Average estimated cost for emergency department poisoning evaluations = \$1245

If Wyoming did not have a poison center, theoretically, all callers in 2011 would have visited an emergency department.

Human poison exposures in 2011 = 5,469

Total cost of emergency department visits = 6,808,905

The majority of exposures were managed safely at home by Wyoming's poison center. In 2011, 3,882 poisoning exposures were managed on-site in a non-health care facility.

The cost savings from the prevention of unnecessary emergency department visits is:
 $3,882 \times \$1,245 = \$4,833,090$

In 2011, the State of Wyoming reduced the cost of poisonings by 71%, resulting in savings of at least **4.8 million dollars**. For every dollar spent on poison center services by the State of Wyoming, there is a return of **one hundred six dollars** in saved health care costs to the consumer. This estimate does not incorporate savings resulting from poison prevention efforts throughout Wyoming, increased efficiency in medical management of poisonings, or reductions in ambulance and inpatient care utilization.

2011 Quality Improvement Report

Case Audit:

Case audit is an important component of the Nebraska Regional Poison Center's quality improvement program. All call records are audited daily by Certified Specialists in Poison Information or the Managing Director. Each case is reviewed to determine whether the call was handled appropriately, to check calculation accuracy and documentation completeness. The purpose of auditing is three-fold:

1. Quality Assurance - to ensure proper case management.
2. Education - to help the employee learn from mistakes or learn how a case might have been handled better. The audit is also used to commend the individual when cases are handled well.
3. Data Collection - to maintain a complete and accurate database of poisoning cases.

Calculation Errors: All assessment calculations are checked for accuracy. If the auditor identifies a calculation error, that case is forwarded to the Managing Director who gives a Calculation Error Report to the Specialist. The error report summarizes the case history, identifies the specific calculation error, and lists what the correct calculation should be. The Managing Director uses the sheets as a teaching tool, especially for new Specialists, to discuss calculations that they may not understand. The error reports are also used to identify calculations that need to be focused on during orientation of new staff. Calculation errors are tracked and integrated into Specialists' performance evaluations.

In 2011, the Wyoming calculation error rate was 0.02% (2 errors out of 8,218 calls handled). None of the calculation errors resulted in case mismanagement.

Management Errors: All cases are evaluated for appropriateness of case management. Most cases are audited the same day of the call, and the auditor takes immediate action to optimize patient outcome when a mismanaged case is identified. Deviation from appropriate case management or follow-up results in a management error. Deviation from medical director-approved clinical triage/treatment protocols (unless the case has been discussed with the on-call toxicologist) results in a management error. Failure to do follow-ups at the time stipulated by the clinical protocol is also considered an error. If the auditor identifies an error, the case is forwarded to the Managing Director who gives a Management Error Report to the Specialist and discusses the case with the Specialist as needed. Management errors are tracked and integrated into Specialists' performance evaluations. The error reports have been used to identify problem areas in case management, which are then discussed with staff. The errors have also stimulated the development of new or revised protocols.

In 2011, there were no Wyoming management errors.

2011 Quality Improvement Report

Additional Quality Assurance Activities:

In addition to the regular audit process, all Wyoming hospitalized cases are reviewed by the Medical Director, Dr. Ronald Kirschner. Feedback is then provided to the staff regarding management of those cases. Also, Dr. Kirschner and Dr. Barthold do regular “rounds” with NRPC staff, which is a discussion of the hospitalized cases being followed by staff. The “rounds” involve interactive discussion of the treatment plan and essential information needed during case follow-up.

The Nebraska Regional Poison Center conducted client satisfaction surveying in 2011. Surveys were periodically sent to a random portion of non-health care professional callers. Results are used to monitor overall satisfaction with NRPC. A scale from one (poor) to six (excellent) is used.






