## IMPROV Provider Portal User Update

### Provider Renewal Applications for Re-certification

An updated online application process for "New" providers as well as "Renewal" providers seeking re-certification has been implemented. Provider Validation Numbers (PVNs) are no longer issued. Access to the remodeled electronic application within the Information Management for (IMPROV) "live" **Providers** Provider Portal https://health.wyo.gov/behavioralhealth/mhsa/certification/. Division recommendation is that providers study the information provided at this website by selecting the appropriate toggle, or brown "box" for guidance, as well as access to the online certification application. Providers will set up a username and password, which will be retained for future use. Providers will receive [gsecure] email communication from the IMPROV system during the set-up process. Provider assistance during the set-up process is available through the Division if needed. Please call the Behavioral Health Division at 1-800-535-4006 and ask for either Colleen or Luke with the Knowledge, Management, Analysis, and Technology (KMAT) technical assistance with IMPROV user set up.

Of significant importance: Renewal applicant users <u>must</u> communicate with the Division via email to the certification program at <u>wdh-certification@wyo.gov</u>, providing the newly generated username (not the password), and the provider's name. This is necessary, only this first time, so that the Division may initially link created usernames with existing electronic provider certification files due to the recent system updates. Upon successful linkage, the Division responds back to providers via email confirming linkage so that successful renewal application work may begin. Providers moving forward in the portal without securing the necessary linking to the appropriate provider's existing file run the risk of electronic information not being received or of the application being rejected.

Division email guidance for renewal providers is sent to the executive director or private business owner on file within IMPROV approximately ninety (90) days ahead of the provider's expiration date. Please watch for this vital communication, and share with appropriate personnel. If within

Electronic communication, via viable email, is necessary to conduct the business of certification, including creating a new username and password for the Provider Portal. Password communication directly from the IMPROV system is sent to users via [gsecure]. Division recommendation is to regularly check your spam email folder(s) and/or add the above email addresses to your 'safe contacts' listings.

## Naloxone for First Responder Entities

#### FREE NARCAN® Nasal Spray- OpiWyo.org

The Wyoming Department of Health (WDH), Public Health Division (PDH), Substance Abuse Prevention Program has received federal funding to supply first responder entities with NARCAN® (naloxone HCl) Nasal Spray and kits at NO COST to the entity. This medication is FDA-approved for the emergency treatment of a known or suspected opioid overdose. The WDH has been supplying statewide law enforcement and first responder agencies with NARCAN® Nasal Spray since November 2017.

The WDH PDH is looking to build further community resources by reaching out to agencies who will consider taking advantage of the naloxone distribution. Agencies could receive training, NARCAN® Nasal Spray, and kits all supplied at no cost. In accordance with State Statute § 35-4-904 and the Wyoming Administrative Rules, Chapter 1: Naloxone Policy and Reporting, entities would be required to create a policy regarding the carrying and administering naloxone, obtain a standing order/prescription from a health care provider, receive training, and agree to report any use of NARCAN® Nasal Spray to the WDH.

Providers must ensure ability to upload electronic copies of all required documentation within the electronic, online application process. Division recommendation is that providers, if possible, convert all electronic documentation to be uploaded into the online applications, into Portable Document Format (PDF). Portable Document Format is a file

format used to present and exchange documents reliably, independent of software, hardware, or operating system.
