

Supportive Services Program as authorized under the Older Americans Act (OAA) of 1965 as Amended in 2016 (Public Law 109-365)

Authorized under the [Older Americans Act](#), Title III-B services are described in Section 321 with emphasis on identifying and serving low income, rural, minority and limited English proficient older individuals.

Major focus: Older adults, over 60, that are at risk, with the greatest economic need, and that have limited English proficiency.

WHO: Who is eligible for this program?

- 1) Eligible participants are individuals who are 60 years of age and older.
- 2) Title III-B Grantees are part of the community senior network which enables older individuals to maintain physical, mental and social well-being through programs designed to meet their needs.
- 3) Priority shall be given to those older individuals who reside in rural areas, those who have the great economic and/or social needs, those with severe disabilities, those with limited English-speaking ability and those with Alzheimer's disease and related disorders with neurological and organic brain dysfunction. (OAA Title III Section. 307 (16) (A)).

WHAT: What services are provided under Title III-B Supportive Services?

Primary Services Provided:

- Health Education and Preventive Health Services;
- Socialization Services;
- Supportive Services; and
- Transportation Services.

WHERE: Where are services provided?

Title III-B Services can be provided in a variety of settings. The services can be given through a single source such as a senior center, recreation center or hospital or in partnerships with another agency. Note: if a service is provided by someone other than the grantee, a contract has to be in place between the grantee and the person or agency providing the service prior to the services being provided. The grantee is responsible to oversee the services the contactor would be providing.

WHY: Why are these services provided?

Supportive Services programs consist of a wide variety of supportive services to enrich and stabilize the lives of older individuals. By providing health education, information and referral, advocacy services, and assistance in addressing issues that face the older adult, older individuals can continue to live independently with self-reliance.

HOW: How are the services provided?

Title III-B Services are designed by each senior center to meet the community's need. Senior centers in your community are the best resources for available III-B services and service schedules.
