Public and Tribal notice is hereby given that the Wyoming Department of Health (WDH) intends to submit renewal applications for its current 1915 (b) & (c) Care Management Entity (CME) Waivers, entitled *Wyoming Medicaid's Youth Initiative-A High fidelity wraparound (HFWA) Community-Based Alternative for Youth with Serious Emotional/Behavioral Challenges (WY-01)*, on March 26th, 2018. The renewal is necessary to continue the federal authority under the 1915 (b) & (c) to extend the CME program beyond June 30, 2019.
