Introduction

During the 2019 General Session, the Wyoming Legislature passed, and Governor Gordon signed into law, Senate File 150 (Senate Enrolled Act 73), Health Care Innovation Studies. The Legislature made a one-time appropriation of \$1,000,000 to the Wyoming Department of Health for the purposes of carrying out health care innovation studies. These studies must aim to achieve the following, per the newly-created Wyoming Statute 9-2-128:

- Reduction of costs associated with long-term care, chronic disease or other health care services to the state of Wyoming;
- Allowing individuals in need of long-term care to remain in their homes and communities;
- Developing necessary long-term care or other health care services in Wyoming; or,
- Use of broadband internet to access health care services.

The Wyoming Department of Health is charged with administering the health care innovation account, establishing rules to carry out health care innovation studies, and establishing the form and manner of application.

APPLICATIONS FOR HEALTH CARE INNOVATION FUNDS

1. APPLICATION PERIOD

- The application period will be open from January 2nd, 2020 through June 30th, 2020.
- 1.2 The Wyoming Department of Health ("the Department") will review all applications received after the application period has closed.
- 1.3 Applications received after the application period has closed will not be considered.

2 SUBMISSION

- 2.2 Applications must contain all information specified in Sections 3 through 10, below.
 - 2.2.1 Responses to each section must appear in the order specified.
 - 2.2.2 Responses to each section must be clearly numbered.

3 APPLICANT INFORMATION

- 3.1 Name of the entity applying, including any subsidiary or proposed sub-contractor information.
- 3.2 Identify a single point of contact for all correspondence for the application materials, including:
 - 3.2.1 Name, role, phone, & email.

4 STAFFING

- 4.1 Identify the primary investigator (PI) responsible for directing study activities.
 - 4.1.1 Name, role, phone, & email.
 - 4.1.2 Summary of qualifications, experience, and capacity. A resume or curriculum vitae may satisfy this requirement.
 - 4.1.3 Any healthcare or other licenses held in Wyoming or any other state.
 - 4.1.4 Signed attestation stating if any adverse action has ever been taken against the PI's license, in Wyoming or any other state.
- 4.2 All staff involved in study activities.
 - 4.2.1 Names, roles, phones, and emails.
 - 4.2.2 Summary of qualifications, experience, and capacity to conduct the study. A resume or curriculum vitae may satisfy this requirement.

- 4.2.3 Any licenses held in Wyoming or any other state.
- 4.2.4 Signed attestation from each staff member stating if any adverse action has ever been taken against the individual's license, in Wyoming or any other state.
- 4.3 Any contractors or subsidiaries currently involved or contemplated for involvement in study activities.

- 5.2 Summary of similar, existing services or models of service delivery currently available in Wyoming, including existing providers and geographic availability.
