## Funding and Technical Assistance Opportunities

## Wyoming State Loan Repayment Program Application Period Now Open

The Wyoming State Loan Repayment Program (WY-SLRP) is accepting applications through **January 31**, **2020**. The 2019 WY-SLRP application and guidance document is available online

WY-SLRP is available to primary care physicians and psychiatrists, primary care and behavioral health physician assistants and nurse practitioners, certified nurse midwives, and mental health clinicians practicing full-time at an approved National Health Service Corps (NHSC) site in a federally designated Health Professional Shortage Area (HPSA).

Physicians and psychiatrists can receive up to \$40,000 in loan repayment and physician assistants, nurse practitioners, certified nurse midwives and mental health clinicians can receive up to \$20,000 in loan repayment in exchange for 2 years of full-time service at an approved NHSC site.

#### **Rural Health Care Coordination Program**

The Health Resources and Services Administration (HRSA) is accepting applications for fiscal year (FY) 2020 Rural Health Care Coordination Program. The purpose of this program is to support rural health consortiums aiming to improve access and quality of care through application of care coordination strategies with the focus areas of collaboration, leadership and workforce, improved outcomes, and sustainability in rural communities.

- Maximum Award:\$250,000/yr

## Rural Domestic Violence, Dating Violence, Sexual Assault, and Stalking Program Department of Justice

This funding opportunity from the US Department of Justice seeks to enhance the safety of rural victims of domestic violence, dating violence, sexual assault, and stalking and support projects uniquely designed to address and prevent these crimes in rural areas. This program encourages collaboration among criminal justice agencies, victim services providers, social services agencies, health professionals, and other community organizations to overcome the problems of domestic violence, dating violence, sexual assault, and stalking in rural communities.

- Maximum Award:\$750,000
- Eligible Applicants:
  - Public and State controlled institutions of higher education
  - Native American tribal governments (Federally recognized)
  - Native American tribal organizations (other than Federally recognized tribal governments)
  - Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education
  - County governments
  - City or township governments
  - State governments
  - Special district governments

#### **Grants for Outreach and Services to Underserved Populations**

This funding opportunity from the US Department of Justice seeks to develop and implement outreach strategies targeted at, and provide victim services to, adult and youth victims of domestic violence, dating violence, sexual assault, or stalking in underserved populations. Grant funds are used to provide victims services to underserved populations; build the capacity of both mainstream organizations and organizations serving underserved populations to provide population specific victim services; and training and outreach activities targeted at agencies and organizations to better serve victims in underserved communities.
