- It must be demonstrated that the awardee is actively involved in their local service in conducting quality improvement, the development of protocols and standing orders, education and training (both initial and continuing) and system wide development.

### Basis for the Award

Established in 1983, the EMS Physician Medical Director of the Year is given in recognition of a Wyoming physician that has provided outstanding leadership and guidance to their local Emergency Medical Service. The award recognizes the *totality* of the physician's contribution to their local service, community and to EMS across Wyoming.
