#### PROJECTS FOR ASSISTANCE IN TRANSITION FROM HOMELESSNESS (PATH) AGREEMENT

I hereby certify that the State/Territory of Wyoming agrees to the following:

**Section 522(a).** Amounts received under the PATH Formula Grant Program will be expended solely for making grants to political subdivisions of the State, and to nonprofit private entities (including community-based veterans organizations and other community organizations) for the purpose of providing the services specified in Section 522(b) to individuals who:

- · Are suffering from serious mental illness; or
- · Are suffering from serious mental illness and from a substance use disorder; and
- · Are homeless or at imminent risk of becoming homeless.

Section 522(b). Entities receiving grants under the PATH Formula Grant Program will expend funds for the following services:

- · Outreach;
- · Screening and diagnostic treatment;
- · Habilitation and rehabilitation;
- · Community mental health;
- · Alcohol or drug treatment;
- Staff training, including the training of individuals who work in shelters, mental health clinics, substance abuse programs, and other sites where homeless individuals require services;
- · Case management services, including:
  - Preparing a plan for the provision of community mental health services to the eligible homeless individual involved, and reviewing such plan not less than once every 3 months;
  - Providing assistance in obtaining and coordinating social and maintenance services for the eligible homeless individuals, including services relating to daily living activities, personal financial planning, transportation services, and habilitation and rehabilitation services, prevocational and vocational services, and housing;
  - Providing assistance to the eligible homeless individual in obtaining income support services, including housing
    assistance, food stamps, and supplemental security income benefits;
  - · Referring the eligible homeless individual for such other services as may be appropriate; and
  - Providing representative payee services in accordance with Section 1631(a) (2) of the Social Security Act if the eligible homeless individual is receiving aid under Title XVI of such act and if the applicant is designated by the Secretary to provide such services.
- · Supportive and supervisory services in residential settings;
- · Referrals for primary health services, job training, education services and relevant housing services;
- Housing services [subject to Section 522(h)(1)] including:
  - · Minor renovation, expansion, and repair of housing;
  - Planning of housing;
  - · Technical assistance in applying for housing assistance;
  - Improving the coordination of housing services;
  - Security deposits;
  - · The costs associated with matching eligible homeless individuals with appropriate housing situations;
  - $\circ~$  One-time rental payments to prevent eviction; and
- Other appropriate services, as determined by the Secretary.

**Section 522(c).** The State will make grants pursuant to Section 522(a) only to entities that have the capacity to provide, directly through arrangements, the services specified in Section 522(b), including coordinating the provision of services in order to meet the needs of eligible homeless individuals who are both mentally ill and suffering from a substance abuse disorder.

Section 522(d). In making grants to entities pursuant to Section 522(a), the State will give special consideration to entities with a demonstrated effectiveness in serving homeless veterans.

Section 522(e). The state agrees that grants pursuant to Section 522(a) will not be made to any entity that:

I hereby certify that the State/Territory of Wyoming agrees to the following:

Section 522(a). Amounts received under the PATH Formula Grant Program will be expended solely for making grants to political subdivisions of the State; and to nonprofit private entities (including community-based veterans organizations and other community organizations) for the purpose of providing the services specified in Section 522(b) to individuals who:

- · Are suffering from serious mental illness; or
- · Are suffering from serious mental illness and from a substance use disorder; and
- · Are homeless or at imminent risk of becoming homeless.

Section 522(b). Entities receiving grants under the PATH Formula Grant Program will expend funds for the following services:

- Outreach:
- Screening and diagnostic treatment;
- · Habilitation and rehabilitation;
- · Community mental health;
- Alcohol or drug treatment;
- Staff training, including the training of individuals who work in shelters, mental health clinics, substance abuse programs, and other sites
  where homeless individuals require services;
- : 'Case management services, including:
  - Preparing a plan for the provision of community mental health services to the eligible homeless individual involved, and
    reviewing such plan not less than once every 3 months;
  - Providing assistance in obtaining and coordinating social and maintenance services for the eligible homeless individuals, including services relating to daily living activities, personal financial planning, transportation services, and habilitation and rehabilitation services, prevocational and vocational services, and housing;
  - Providing assistance to the eligible homeless individual in obtaining income support services, including housing
    assistance, food stamps, and supplemental security income benefits;
  - · Referring the eligible homeless individual for such other services as may be appropriate; and
  - Providing representative payee services in accordance with Section 1631(a) (2) of the Social Security Act if the eligible
    homeless individual is receiving ald under Title XVI of such act and if the applicant is designated by the Secretary to
    provide such services.
- Supportive and supervisory services in residential settings;
- Referrals for primary health services; job training, education services and relevant housing services;
- Housing services (subject to Section 522(h)(1)) including:
  - Minor renovation, expansion, and repair of housing;
  - Planning of housing;
  - Technical assistance in applying for housing assistance;
  - · Improving the coordination of housing services;
  - · Security deposits;
  - The costs associated with matching eligible homeless individuals with appropriate housing situations;
  - · One-time rental payments to prevent eviction; and
- Other appropriate services, as determined by the Secretary.

Section 522(c). The State will make grants pursuant to Section 522(a) only to entities that have the capacity to provide, directly through arrangements, the services specified in Section 522(b), including coordinating the provision of services in order to meet the needs of eligible homeless individuals who are both mentally ill and suffering from a substance abuse disorder.

Section 522(d). In making grants to entitles pursuant to Section 522(a), the State will give special consideration to entities with a demonstrated effectiveness in serving homeless veterans.

Section 522(e). The state agrees that grants pursuant to:Section 522(a) will not be made to any entity that:

- · Has a policy of excluding individuals from mental health services due to the existence or suspicion of a substance use disorder; or
- · Has a policy of excluding individuals from substance use services due to the existence or suspicion of mental illness.

Section 522(f). Not more than four (4) percent of the payments received under the PATH Formula Grant Program will be expended for administrative expenses regarding the payments.

Section 522(h). The State agrees that not more than 20 percent of the payments will be expended for housing services under section 522(b)(10); and the payments will not be expended for the following:

- · To support emergency shelters or construction of housing facilities;
- · For inpatient psychiatric treatment costs or inpatient substance use treatment costs; or
- · To make cash payments to intended recipients of mental health or substance use services.

Section 523(a). The State will make available, directly or through donations from public or private entities, non-Federal contributions toward such costs in an amount that is not less than \$1 for each \$3 of funds provided in such payments. The amount of non-Federal contributions shall be determined in accordance with Section 523(b).

Section 523(c): The State will not require the entities to which grants are provided pursuant to Section 522(a) to provide non-Federal contributions in excess of the non-Federal contributions described in Section 523(a).

Section 526. The State has attached hereto a Statement that does the following:

- Identifies existing programs providing services and housing to eligible homeless individuals and gaps in the delivery systems of such programs;
- · Includes a plan for providing services and housing to eligible homeless individuals, which:
  - Describes the coordinated and comprehensive means of providing services and housing to homeless individuals; and
  - Includes documentation that suitable housing for eligible homeless individuals will accompany the provision of services to such individuals;
- Describes the source of the non-Federal contributions described in Section 523;
- Contains assurances that the non-Federal contributions described in Section 523 will be available at the beginning of the grant period;
- · Describes any voucher system that may be used to carry out this part; and
- · Contains such other information or assurances as the Secretary may reasonably require

Section 527(a)(1), (2), and (3). The State has attached hereto a description of the intended use of PATH Formula grant amounts for which the State is applying. This description shall:

- Identify the geographic areas within the State in which the greatest numbers of homeless individuals with a need for mental health, substance use, and housing services are located; and
- Provide information relating to the program and activities to be supported and services to be provided, including information relating to coordinating such programs and activities with any similar programs and activities of public and private entities.

Section.527(a)(4). The description of intended use for the fiscal year of the amounts for which the State is applying will be revised throughout the year as may be necessary to reflect substantial changes in the programs and activities assisted by the State pursuant to the PATH Formula Grant Program.

Section 527(b). In developing and carrying out the description required in Section 527(a), the State will provide public notice with respect to the description (including any revisions) and such opportunities as may be necessary to provide interested clients, such as family members, consumers and mental health, substance use, and housing agencies, an opportunity to present comments and recommendations with respect to the description.

Section 527(c)(1)(2). The services to be provided pursuant to the description of the intended use required in Section 527(a), have been considered in the preparation of, have been included in, and are consistent with the State Plan for Comprehensive Community Mental Health Services under P.L. 102-321.

Section 528(a). The State will, by January 31, 2021, prepare and submit a report providing such information as is necessary for the following:

- To secure a record and description of the purposes for which amounts received under the PATH Formula Grant Program were expended during fiscal year 2018 and of the recipients of such amounts; and
- To determine whether such amounts were expended in accordance with the provisions of Part C PATH.

Section 528(b). The State further agrees that it will make copies of the reports described in Section 528(a) available for public inspection.

Section 529. Payments may not be made unless the State agreements are made through certification from the chief executive officer of the State.

Wyoming PATH programs prioritize persons with serious mental illness, including those with cooccurring substance abuse disorder who have experienced chronic homelessness, and veterans who are homeless. Alliances with criminal justice and other institutional settings provide better practices for housing the people entering and leaving care. Mental health and substance use disorder treatment and recovery services are available with PATH case managers. Case managers facilitating entry into low or no-cost treatment services.

The Division and the PATH program continue to champion the expansion of Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI) Outreach, Access, and Recovery (SOAR) including efforts to adopt recommendations from the SOAR Leadership Academy (SOAR-LA). Alliance with Wyoming's Housing and Urban Development (HUD), HUD Continuum of Care (CoC), the Wyoming Homeless Collaborative (WHC), continues to improve utilization of the Homeless Management Information System (HMIS), completion of the annual Point in Time (PIT) count and PATH's participation in a coordinated entry, which is designed to prioritize the people served through PATH. Each PATH provider is encouraged to seek collaboration with CoC. State-level staff diligently provide programmatic and fiscal guidance and oversight to ensure outputs and outcomes are achieved while adhering to rules and regulations.

Through Wyoming's PATH Request for Applications (RFA) process, street outreach and case management were identified as core functions that must be provided within each provider's PATH program. Street outreach and Case Management, as defined by PATH, are included as deliverables within each provider contract and statement of work (SOW).

Outreach is a service required by providers to travel and visit individuals who are literally homeless and those experiencing homelessness in frequent homeless areas on a weekly basis. Targets are set for the number of persons to be outreached. Outreach personnel utilize "tools of engagement" to build the trust and rapport of individuals who are homeless, in hopes to lead to opportunities to assess their needs, including needs for mental health, substance use, and other health services.

Once an individual's eligibility for PATH funded services is established and the individual enrolls in the PATH program, Case Management services are rendered. Target numbers to be PATH enrolled and housed are also set in each provider contract and SOW. Priority is placed for individuals who have histories of chronic homelessness and those with situations that place them at increased vulnerability. Case Managers utilize evidence-based practice skills, such as motivational interviewing. These Case Management services play an integral part in assisting the individual to stay connected to community services that enhance recovery outcomes. Guidance on PATH identified case management services has been given to each provider and is reviewed frequently.

Wyoming utilizes a Housing First approach to house individuals in community settings as quickly as possible, and then provide services as needed and as dictated by the individual being served. Housing is not contingent upon receiving PATH services; however, Case Management services are offered as a way to establish long-term resources. Frequently, PATH participants and Case Managers form long-lasting and significant helpful relationships. 

The Wyoming Department of Health, Behavioral Health Division (Division) provides programmatic and fiscal oversight of the PATH Subrecipients through on-site reviews, desk audits, and monthly reporting. At a minimum, annual site visits are conducted by the State PATH Program Manager who utilizes the onsite review material provided by the PATH resource center, and the Wyoming Department of Health Grants Policies and Procedures. Grantees are provided timely feedback.

Monthly invoices and reports record numbers outreached and provided PATH Case Management, numbers housed and continued to be housed, utilization of SOAR, and other input and outcome measures. PATH requires fiscal information to be tracked, including the 1:3 local match, and the twenty percent (20%) maximum for housing.

Onsite reviews and desk audits focus on programmatic issues including short-term and long-term planning, problem solving, outreach issues, use of best practices, examples from other communities and training needs. Onsite reviews include a review of contract compliance, consistency with PATH rules and regulations, staff interviews, meetings with consumers, fiscal review, and participant record reviews. The participant records review includes a review of the case management details, individualized plans, and fiscal records for each individual participant. Onsite reviews are also used to identify possible technical assistance needs, including problem solving for systemic issues. Technical assistance from the Division is available throughout the year.

The Division's Grant and Program Unit Manager, also known as the State PATH Program Manager, is responsible for ensuring PATH services are integrated with other services funded by the Division and provide a seamless continuum of care.

The Division utilizes a culture of performance management. Performance improvement for State contracted providers is advanced through continuous monitoring of data and other information received from providers and the development of performance improvement plans, as necessary, to ensure contract deliverables and program objectives are met.

A State PATH RFA was distributed in April 2020, utilizing a statewide competitive grant process. Notification was given to all previous providers, including the Eastern Shoshone Recovery Program (ESRP). Notice was sent to a person inquiring about the services and was posted on the Division web page.

The Behavioral Health Division (Division) received five (5) PATH application, all of which were from previous PATH providers. All five (5) providers have experience in providing services to persons experiencing homelessness and who have a serious mental illness or co-occurring substance use disorder. Applications were also received from the ESRP.

These providers represent Wyoming's five largest counties (about fifty-three (53%) of the State's population). The combined applications report numbers that demonstrate their commitment to outreach and enrolling persons who are homeless and who have a serious mental illness or co-occurring substance use disorder.

The Division proposes to fund five (5) providers with PATH funds. MHBG funds, totaling \$100,000 over two years, to help support mental health services and case management services. Along with the PATH funds and MHBG, State General Funds (SGF) will be utilized to assist all housing costs. ESRP serves tribal members who live near or on the Wind River Indian Reservation. Wyoming's population of five hundred seventy-eight thousand, seven hundred fifty-nine (578,759) (2019 census estimate) occupies the ninety-seven thousand, nine hundred fourteen (97,914) square miles of high mountains, rolling plains, and barren desert. Out of Wyoming's twenty-three (23) counties, five (5) PATH counties hold approximately fifty-three percent (53%) of the population.

The first Wyoming Point In Time (PIT) count was conducted in 2014 and continues each year

since. The challenges of conducting the PIT count include the very rural and frontier nature of the State, few service providers in many parts of the State and the small number of organizations directly involved with homelessness work. Another challenge is recruiting individuals and organizations within these communities to organize and conduct the count. However, the Wyoming Homeless Collaborative (WHC) has made great strides in improving reliability of the count. The WHC continues to improve the organization of PIT and includes this goal in its performance improvement plan.

The MHBG provides funding to support four of the PATH Housing First projects. Each provider The Mental Health Block Grant (MHBG) provides funding to support four (4) of the PATH Housing First projects. Each provider will receive MHBG funds in the amount of \$20,000 used for PATH Case Management services and mental health-related services.

State General Funds totaling \$100,000 are utilized to supplement PATH services.

The Behavioral Health Division (Division) supports the statewide SOAR initiative. The previous State PATH Program Manager was the lead for SOAR and had completed the SOAR-LA, she has since retired from the position. The current State PATH Program Manager has not completed SOAR training. Four (4) of the five (5) local PATH providers have at least one (1) SOAR trained person, and two (2) of those PATH providers have staff who have completed the SOAR-LA.

The Tribal provider Easterner Shoshone Recovery Program (ESRP) is in need of obtaining SOAR training and has requested assistance within their application to the State. The State will comply with the request. ESRP provided a statement within their application, "ESRP will ensure that at least one staff is trained in SOAR and utilizes the SOAR process to assist participants."

ICA sends monthly HMIS reports to the PATH State Program Manager. ICA is significantly responsive to any requests and provides timely and appropriate technical assistance and support for all HMIS users.

### M. SSI/SSDI Outreach, Access and Recovery (SOAR)

Describe how the state encourages provider staff to be trained in SOAR. Indicate the number of PATH providers who have at least one trained SOAR staff.

The State of Wyoming (State) ensures, through contract, each PATH provider has a minimum of one (1) staff person certified in the use of SOAR. This remains a requirement for each contract.

Four (4) of the five (5) continuing PATH providers have at least one (1) SOAR trained staff. SOAR trained staff promote the use of SOAR by other community service providers to help ensure all individuals who are homeless in their community have access to this service. The use of SOAR will continue to be included as a deliverable in PATH contracts.

Two (2) of Wyoming's PATH programs have staff who have completed the SOAR-LA. Currently, four of the five providers expect one (1) or more individuals to complete SOAR training. A total of six (6) individuals are expected to complete SOAR training across the State.

Eastern Shoshone Recovery Program (ESRP) is in need of obtaining SOAR training and has requested assistance within their application to the State. The State will comply with the request. ESRP has also provided a statement within their application, "ESRP will ensure that at least one (1) staff is trained in SOAR and utilizes the SOAR process to assist participants." ESRP also expects to have a total of two individuals trained in SOAR. Reasoning for failure to obtain SOAR training can be requested and provided.

There continues to be a need for more SOAR trained individuals in the state who are employed by PATH community partners. There is also a need for a full time, dedicated SOAR staff in the State's two (2) larger communities. Too often the need outweighs the capacity of the PATH programs to assist individuals in a timely manner. The State PATH Program Manager will be working to expand the network of agencies utilizing the SOAR model in collaboration with the Continuum of Care.

### N. PATH Eligibility and Enrollment

Often a potential participant is identified via outreach efforts or through the Vulnerability Index - Service Prioritization Decision Assistance Tool (or another screening tool), which can be conducted by an outreach worker, community partner, a partner in Wyoming's coordinated entry process, a PATH staff, or other PATH Subrecipient staff.

PATH eligibility is determined through a deliberate interaction between the potential participant and the PATH Case Manager to assess eligibility. Eligibility requires three (3) factors:

- 1. The participant must have a serious mental illness, which may include a co-occurring substance use disorder:
- 2. The participant must be literally homeless or at imminent risk of homelessness; and
- 3. The participant agrees to be a PATH participant, which does not bind the participant to any specific tasks but does ensure that the participation is not coerced and is voluntary.

Enrollment occurs if the eligible participant agrees to participate in the PATH program. Eligibility is documented in the Homeless Management Information System following the interactive assessment, with each interaction, and upon leaving (dis-enrolling in) the program.
