# **Funding and Technical Assistance Opportunities**

#### **Telehealth Network Grant Program**

Funded by the Health Resources and Services Administration through the Federal Office of Rural Health Policy, this opportunity aims to promote rural Tele-emergency services with an emphasis on tele-stroke, tele-behavioral health, and Tele-Emergency Medical Services (Tele-EMS).

Proposed projects will enable telehealth networks to deliver 24-hour Emergency Department (ED) consultation services via telehealth to rural providers without emergency care specialists.

- Maximum Award:\$300,000 per year
- Eligible Applicants: rural or urban nonprofit entities that will provide direct clinical services through a telehealth network. Each entity participating in the networks may be a non-profit or for-profit entity. Faith-based, community-based organizations and tribal organizations are eligible to apply. Services must be provided to rural areas, although the applicant can be located in an urban area.
- Application Deadline: June 15, 2020

#### 2020 NHSC Scholarship Program

The NHSC Scholarship Program provides scholarships to health profession students pursuing careers as primary care providers in exchange for their commitment to serve in highneed, underserved communities. The scholarship includes tax-free payment of tuition, required fees, other reasonable educational costs, and a taxable monthly living stipend.

- Project Period: 2 years
- Eligible Applicants: Be a U.S. citizen (either U.S. born or naturalized) or U.S. national, be enrolled or accepted for enrollment as a full-time student, not have

After completion of graduation/training, recipients fulfill their service commitment at one of more than 20,000 NHSC-approved sites throughout the nation and its territories. Each scholar serves for a minimum of two years and receives one year of financial support (up to four years) for each year of service at an NHSC-approved site found on the Health Workforce Connector.

# National Health Service Corps Loan Repayment Programs One Application, Three Programs



The National Health Service Corps (NHSC) opened its application for three loan repayment programs: the NHSC Loan Repayment Program, the NHSC Substance Use Disorder Workforce Loan Repayment Program and the NHSC Rural Community Loan Repayment Program.

#### **Nurse Corps Scholarship Program**

The Nurse Corps Scholarship Program (Nurse Corps SP) provides funding to students enrolled in diploma, associate, baccalaureate, or graduate degree nursing programs. The award is in exchange for a commitment to serve in high-need, underserved communities. Scholarship support includes payment of tuition, required fees, other reasonable educational costs, and a monthly living stipend.

- Eligible Applicants: US Citizen or lawful permanent resident nursing students. Applicants cannot have any federal judgment liens and/or existing service commitments and cannot be overdue on a federal debt.
- Application Deadline: April 30, 2020

## Addressing Disparities Research Grants

Funded by the Patient-Centered Outcomes Research Institute, this funding announcement seeks applications from researchers studying the comparative effectiveness of enhanced interventions that reduce or eliminate disparities in health and healthcare. Research may focus on residents of rural areas, low-income groups, and other target populations.

- Maximum Award:\$5,000,000
- Project Period: 3-4 years
- Eligible Applicants: Any public or private research organization. For full details, visit the program <u>website</u>.
