Wyoming Department of Health

Proposed Amendment to Medicaid 1915(c) Children's Mental Health Waiver

Public and Tribal notice is hereby given that the Wyoming Department of Health (WDH) intends to submit an amendment to its current 1915 (c) Children's Mental Health Waiver services delivered by the State's Care Management Entity (CME), with an effective date of January 1, 2021. The amendment is necessary to adjust the agreed upon rate and reimbursement paid by the Department to the CME's direct service providers.

Administration: Will not change.

<u>Eligibility:</u> Will not change.

Services: Will not change.

<u>Payment:</u> Will change. Youth and Family Training & Support services with dates of service January 1, 2021, forward, will be reduced by 2.5%.

Changes in Method and Standards: Will not change.

State Rationale for Proposed Changes:

The WDH, Division of Healthcare Financing (DHCF), is the State appointed entity for administration of Wyoming's Medicaid program and has procured a statewide CME for youth with complex behavioral conditions. The State's budget for waiver services is being reduced by 2.5% of the current reimbursement rate for Youth and Family Training and Support services to comply with the Governor's budget reduction request.

Proposed Implementation Timeline:

Effective for dates of service January 1, 2021, forward, the Agency's fee for service rate for Youth and Family Training & Support will decrease by 2.5% to adhere to the Governor's budget reduction as specified in the State's SFY21-22 biennial budget.

Fiscal Impact:

State – 1.25% rate reduction per service unit for Youth and Family Training & Support services.

Federal - 1.25% rate reduction per service unit for Youth and Family Training &

Support services.
