Title III-E National Family Caregiver Support Program Summary

The Caregiver Program is designed to help Caregivers, 18 years of age and older, get relief from giving care to their loved one. Caregivers of older adults who are 60 and older and loved ones who have dementia and/or alzheimer's at any age. The Caregiver cannot be receiving payment for taking care of a loved one.

The Older Relative Caregiver (ORC) Program is designed to assist ORCs, 55 years and older, who are supporting children 17 years and younger under and adults 18 to 59 who are disabled get relief from giving care to the children and disabled adults.


- Parents of an adult child, 18 to 59, who is disabled are also eligible for this program.



Title III-E National Family Caregiver Support Program Summary

Funding for this program is given to community organizations who are assisting Caregivers and Older Relative Caregiver in many ways across Wyoming. (senior centers, home health agency, WSCI)

Program providers may provide caregivers with supplemental services to compliment the caregivers' activities such as; providing caregivers with information and assistance about available services for older adults, providing individual counseling and training to assist caregivers in decision making, offering respite care to provide temporary relief to caregivers of their responsibilities.



Title III-E Eligibility

Who is Eligible?

- A person who is 18 years of age or older who is taking care of a person 60 years old or older
- A person who is 18 years of age or older who is taking care of a person with Alzheimer's disease or a related dementia at any age
- An Older Relative Caregiver, not a parent, who is at least 55 years old and taking care of a child 17 years old or younger
- An Older Relative Caregiver and/or Parent who is at least 55 years old and taking care of an adult child between the ages of 19-59 living with a disability



National Family Caregiver Support Program - Statistics


Approximately 34.2 million Americans provided unpaid care to an adult age 50 or older in the last 12 months, while 43.5 million provided unpaid care to an adult or child during the same 12-month period. Estimated value of this care \$470 billion.

National Family Caregiver Support Program - Services

- Information: Public education, brochures, posters, general information relative to the program and to resources to support caregivers and their families.
- Assistance: One-to-one contact. This service may include assistance to the caregiver in locating and arranging for services from a variety of agencies. Also addressed is the Care Coordination ~ assessment of the needs of the caregiver. Included is the development of service plans, assessment and reassessment.
- Counseling/Training/Support Groups: Training is implemented to provide advice, guidance, and education, etc., to caregivers in individual or group settings. Support Groups for Caregivers to share their Caregiving experiences and talk. Counseling may only be done by a licensed counselor to be billed to the program.

National Family Caregiver Support Program - Services

- Respite: Child day care, In-home services, adult day care, or if need be, an overnight stay in a residential setting which might be a nursing home or assisted living. This service is defined as "intermittent" and is intended to be limited.
 - Please do not enter Respite for November 2020 because ACL is changing the services so we will need to change too.
- <u>Supplemental Services:</u> Supplemental services include adaptive equipment (handrails, ramps, lighting, etc.), loan closet items, or meals and transportation for the caregiver. Also included are car repairs, smoke detectors, homemaker and chore services, personal care, <u>or other services approved by the Division</u>. The \$400 limit per year, per client for home modifications and durable medical equipment (DME) can be increased with Division approval.

National Family Caregiver Support Program Required Documents:

- Caregiver/ORC Service Plan- Quarterly and Annually or Change of Status
- ✓ Caregiver/ORC Services Evaluation- Annually or Change of Status
- Caregiver/ORC Information- Annually or Change of Status
- ✓ Caregiver/ORC Evaluation Form- Semi-annually or Change of Status
- ✓ Caregiver Task Sheet- Document provided services

Additional Documentation:

Approval form for Specialized Services or for services over a specific \$\$ amount



National Family Caregiver Forms And Assessment Tools

- Aging Needs Evaluation Summary (AGNES) needs to be done for Care Receivers (loved ones), annually and quarterly, whose Caregiver has asked for Respite and Supplemental Services.
- Service Plan needs to be done for all Caregivers, noting services needed. This plan needs to be signed by the Caregiver (client) and the Access Care Coordinator.
 - Caregiver is taking care of two loved ones. ACC needs to do two Service Plans.
- A nursing assessment is required if the ACC determines, via the AGNES, a need for personal care. This assessment is required to be done by a licensed nurse, and if a LPN did the assessment, a RN or physician must also sign. Access Care Coordinators who are not licensed nurses are not qualified to do this assessment.


