Overview

- Breast and Cervical Cancer Screening Program (BCCSP)
 - Funded by the Centers for Disease Control and Prevention
 - Reimburses providers at current Medicare Limiting Charge rate
- Colorectal Cancer Screening Program (CCSP)
 - Funded by State of Wyoming
 - o Reimburses providers at current Medicaid rate





Provider Information

- Must be enrolled with Wyoming Medicaid
- Must submit electronic claims and documentation via electronic claims system





Client Enrollment and Verification

Providers can now check if an individual is enrolled into a program by checking the Medicaid provider portal

Covered CPT and Diagnosis Codes

- Breast and cervical cancer screening codes are provided by CDC guidance
- Colorectal cancer screening codes are outlined in State Statute and Rules
- Most up-to-date version can be found on our website
 - https://health.wyo.gov/publichealth/prevention/cancer/provider-information/
- Codes are updated annually





Claim Submissions and Guidelines

- Providers must submit supporting documentation via electronic claims system
- WCP is payer of last resort for those with primary insurance
- 12 month timely filing restriction





Claims Issues

- Any issues with claims should be communicated directly with Medicaid's provider support
- Additional support available from WCP staff as needed





Client Out of Pocket Expenses

- Providers should discuss any expected out of pocket costs with a client before rendering services
- Providers may not bill clients for any WCP covered services





Additional Services

- Patient navigation for clients who are not eligible
- Referral to community resources
- Transition to Medicaid for breast or cervical cancer treatment





Current BCCSP Client Eligibility

- Wyoming resident
- Female
 - Transgender woman who has taken hormone therapy
 - Transgender man who has not had a bilateral mastectomy or total hysterectomy
- Income of 250% or below Federal Poverty Guidelines
- Uninsured; can not have Medicare part B or Medicaid





BCCSP Changes as of July 1

- Expanding coverage to include underinsured
 - Underinsured means having an out-of-pocket expense they can not afford





BCCSP Client Eligibility as of July 1st

- Wyoming resident
- Female
 - Transgender woman who has taken hormone therapy
 - Transgender man who has not had a bilateral mastectomy or total hysterectomy
- Income of 250% or below Federal Poverty Guidelines
- Uninsured or underinsured; can not have Medicare part B or Medicaid





Cervical Cancer Screening Client Age and Risk Criteria

- Age 21-29 years: Symptomatic or asymptomatic and have not had a Pap test completed within the past three years
- Age 30-64 years: Symptomatic or asymptomatic and have not had a Pap test completed within the past three years, or have not had a primary HPV test within the past 5 years, or have not had co-testing with a Pap test and the HPV test within the past 5 years
- Age 65 and older: Applicants without Medicare part B are eligible.





Breast Cancer Screening Client Age and Risk Criteria

- Age 18-39 years: Symptomatic or asymptomatic and high-risk
- Age 40-64 years: No additional requirements
- Age 65 or older: Applicants without Medicare part B are eligible






Current CCSP Client Eligibility

- Wyoming resident for 1 year
- Income of 250% or below Federal Poverty Guidelines
- Can be uninsured or have private medical insurance coverage
 - Can not be covered by Medicaid or have become eligible for the Federal Medicare Programs
- Covers colonoscopy only











CCSP Changes as of July 1

- Age 50 or older
- May now utilize an at home stool-based test

All patients should discuss screening options with their provider to determine which test is right for them.





CCSP Client Eligibility as of July 1

- Age 50 or older
- Wyoming resident for 1 year
- Income of 250% or below Federal Poverty Guidelines
- Can be uninsured or have private medical insurance coverage
 - Can not be covered by Medicaid or have become eligible for the Federal Medicare Programs
- May receive an at home stool-based test or colonoscopy


