The law does not apply to children's services provided in private residence, portions of facilities used for inpatient drug or alcohol treatment, service providers whose sole source of applicable Federal funds is Medicare or Medicaid, or facilities where WIC coupons are redeemed.

Failure to comply with the provisions of the law may result in the imposition of a civil monetary penalty of up to \$1,000 for each violation and/or the imposition of an administrative compliance order on the responsible entity.

By signing the certification, the undersigned certifies that the applicant organization will comply with the requirements of the Act and will not allow smoking within any portion of any indoor facility used for the provision of services for children as defined by the Act.

The applicant organization agrees that it will require that the language of this certification be included in any subawards which contain provisions for children's services and that all subrecipients shall certify accordingly.

The Public Health Services strongly encourages all grant recipients to provide a smoke-free workplace and promote the non-use of tobacco products. This is consistent with the PHS mission to protect and advance the physical and mental health of the American people.

#### **Funding Agreement**

#### **FISCAL YEAR 2021**

#### PROJECTS FOR ASSISTANCE IN TRANSITION FROM HOMELESSNESS (PATH) AGREEMENT

I hereby certify that the State/Territory of Wyoming agrees to the following:

**Section 522(a).** Amounts received under the PATH Formula Grant Program will be expended solely for making grants to political subdivisions of the State, and to nonprofit private entities (including community-based veterans organizations and other community organizations) for the purpose of providing the services specified in Section 522(b) to individuals who:

- · Are suffering from serious mental illness; or
- · Are suffering from serious mental illness and from a substance use disorder; and
- · Are homeless or at imminent risk of becoming homeless.

Section 522(b). Entities receiving grants under the PATH Formula Grant Program will expend funds for the following services:

- · Outreach;
- · Screening and diagnostic treatment;
- · Habilitation and rehabilitation;
- · Community mental health;
- · Alcohol or drug treatment;
- Staff training, including the training of individuals who work in shelters, mental health clinics, substance abuse programs, and other sites where homeless individuals require services;
- · Case management services, including:
  - Preparing a plan for the provision of community mental health services to the eligible homeless individual involved, and reviewing such plan not less than once every 3 months;
  - Providing assistance in obtaining and coordinating social and maintenance services for the eligible homeless individuals, including services relating to daily living activities, personal financial planning, transportation services, and habilitation and rehabilitation services, prevocational and vocational services, and housing;
  - Providing assistance to the eligible homeless individual in obtaining income support services, including housing assistance, food stamps, and supplemental security income benefits;
  - · Referring the eligible homeless individual for such other services as may be appropriate; and
  - Providing representative payee services in accordance with Section 1631(a) (2) of the Social Security Act if the eligible homeless individual is receiving aid under Title XVI of such act and if the applicant is designated by the Secretary to provide such services.
- · Supportive and supervisory services in residential settings;
- · Referrals for primary health services, job training, education services and relevant housing services;
- Housing services [subject to Section 522(h)(1)] including:
  - · Minor renovation, expansion, and repair of housing;
  - Planning of housing;
  - · Technical assistance in applying for housing assistance;
  - Improving the coordination of housing services;
  - Security deposits;
  - · The costs associated with matching eligible homeless individuals with appropriate housing situations;
  - $\circ~$  One-time rental payments to prevent eviction; and
- Other appropriate services, as determined by the Secretary.

**Section 522(c).** The State will make grants pursuant to Section 522(a) only to entities that have the capacity to provide, directly through arrangements, the services specified in Section 522(b), including coordinating the provision of services in order to meet the needs of eligible homeless individuals who are both mentally ill and suffering from a substance abuse disorder.

Section 522(d). In making grants to entities pursuant to Section 522(a), the State will give special consideration to entities with a demonstrated effectiveness in serving homeless veterans.

Section 522(e). The state agrees that grants pursuant to Section 522(a) will not be made to any entity that:

- · Has a policy of excluding individuals from mental health services due to the existence or suspicion of a substance use disorder; or
- · Has a policy of excluding individuals from substance use services due to the existence or suspicion of mental illness.

Section 522(f). Not more than four (4) percent of the payments received under the PATH Formula Grant Program will be expended for administrative expenses regarding the payments.

Section 522(h). The State agrees that not more than 20 percent of the payments will be expended for housing services under section 522(b)(10); and the payments will not be expended for the following:

- · To support emergency shelters or construction of housing facilities;
- · For inpatient psychiatric treatment costs or inpatient substance use treatment costs; or
- · To make cash payments to intended recipients of mental health or substance use services.

**Section 523(a).** The State will make available, directly or through donations from public or private entities, non-Federal contributions toward such costs in an amount that is not less than \$1 for each \$3 of funds provided in such payments. The amount of non-Federal contributions shall be determined in accordance with Section 523(b).

Section 523(c). The State will not require the entities to which grants are provided pursuant to Section 522(a) to provide non-Federal contributions in excess of the non-Federal contributions described in Section 523(a).

Section 526. The State has attached hereto a Statement that does the following:

- Identifies existing programs providing services and housing to eligible homeless individuals and gaps in the delivery systems of such programs;
- · Includes a plan for providing services and housing to eligible homeless individuals, which:
  - · Describes the coordinated and comprehensive means of providing services and housing to homeless individuals; and
  - Includes documentation that suitable housing for eligible homeless individuals will accompany the provision of services to such individuals;
- Describes the source of the non-Federal contributions described in Section 523;
- · Contains assurances that the non-Federal contributions described in Section 523 will be available at the beginning of the grant period;
- Describes any voucher system that may be used to carry out this part; and
- Contains such other information or assurances as the Secretary may reasonably require.

Section 527(a)(1), (2), and (3). The State has attached hereto a description of the intended use of PATH Formula grant amounts for which the State is applying. This description shall:

- Identify the geographic areas within the State in which the greatest numbers of homeless individuals with a need for mental health, substance use, and housing services are located; and
- Provide information relating to the program and activities to be supported and services to be provided, including information relating to coordinating such programs and activities with any similar programs and activities of public and private entities.

**Section 527(a)(4).** The description of intended use for the fiscal year of the amounts for which the State is applying will be revised throughout the year as may be necessary to reflect substantial changes in the programs and activities assisted by the State pursuant to the PATH Formula Grant Program.

**Section 527(b).** In developing and carrying out the description required in Section 527(a), the State will provide public notice with respect to the description (including any revisions) and such opportunities as may be necessary to provide interested clients, such as family members, consumers and mental health, substance use, and housing agencies, an opportunity to present comments and recommendations with respect to the description.

Section 527(c)(1)(2). The services to be provided pursuant to the description of the intended use required in Section 527(a), have been considered in the preparation of, have been included in, and are consistent with the State Plan for Comprehensive Community Mental Health Services under P.L. 102-321.

Section 528(a). The State will, by January 31, 2022, prepare and submit a report providing such information as is necessary for the following:

- To secure a record and description of the purposes for which amounts received under the PATH Formula Grant Program were expended during fiscal year 2018 and of the recipients of such amounts; and
- To determine whether such amounts were expended in accordance with the provisions of Part C PATH.

Section 528(b). The State further agrees that it will make copies of the reports described in Section 528(a) available for public inspection.

Section 529. Payments may not be made unless the State agreements are made through certification from the chief executive officer of the State.

Wyoming PATH Programs prioritize individuals with serious mental illness, including those with co-occurring substance abuse disorder who have experienced chronic homelessness, and veterans who are homeless. Alliances with criminal justice and other institutional settings provide better practices for housing individuals entering and leaving care. Mental health and substance use disorder treatment and recovery services are available with PATH case managers who facilitate entry into low or no-cost treatment services.

The Division and the PATH Program continue to champion the expansion of Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI) Outreach, Access, and Recovery (SOAR) including efforts to adopt recommendations from the SOAR Leadership Academy (SOAR-LA). Alliance with Wyoming's Housing and Urban Development (HUD), HUD Continuum of Care (CoC), the Wyoming Homeless Collaborative (WHC), continues to improve utilization of the Homeless Management Information System (HMIS), completion of the annual Point in Time (PIT) count and PATH's participation in a coordinated entry, which is designed to prioritize the people served through PATH. These changes do not exceed 25%; the highest change is approximately 20%. Per our conversation, we had discussed if there was over a 25% change then we would indeed need to change the IUPs. Due to being under 25%, Wyoming should not need to change the IUPs. Additional information: Background: Eastern Shoshone Recovery Program would like to subcontract with the Eastern Shoshone Red Feathered Eagle Voc Rehab entity. ESRP plans to assist ESRFEVR in data collection through HMIS and reporting in the PDX, along with assisting ESRFEVR in how to do the outreach and housing portion. ESRFEVR currently works with ESRP with their SOAR applications. This group has collaborated before, but not in a contract sense. When I spoke to the ESRP, they felt the PATH Grant would be better suited with the ESRFEVR and would like for ESRFEVR to take over the PATH Grant in their area, in Fall of 2023 (new contracting year). # A. Local Provider Description

Community Action Partnership of Natrona County (CAPNC) has provided human services to Natrona County for over 37 years. Our mission is to empower individuals to become self-sufficient by reducing poverty and homelessness and promoting physical and mental health in collaboration with other human service agencies. We are the human service arm of the Natrona County through the Board of County Commissioners. Our local officials have charged us and our community to conduct regular needs assessments and determine which human services are needed to support local citizens. In response to the needs assessments, we have developed a total program that,, in addition to the Projects for Assistance in Transition from Homelessness (PATH) program, provides the following: primary medical care, mental health services, emergency rental assistance, permanent supportive housing, employment preparedness (interview skills, resume/application skills), financial and budgeting education, and Supplemental Security Income (SSI) and Social Disability Insurance (SSDI) assistance by a SSI/SSDI Outreach, Access, and Recovery (SOAR) trained representative. We collaborate with other organizations when we cannot provide the service directly, such as dental care, vision care, and substance use disorder services. Historically, CAPNC serves 1,300 unduplicated individuals a year.

CAP-NC will provide PATH services in the Central Region of Wyoming, specifically within Natrona County; population 79,556.

# B. Collaboration with HUD Continuum of Care (CoC) Program

CAP-NC is a member of Wyoming's Continuum of Care (COC) and Wyoming Homeless Collaborative. Staff actively participates in all meetings and is part of the WY COC

System Performance Data Committee. The Data Committee is responsible for the oversight of the HMIS Lead for data quality. They review data quality reports, work with the HMIS Lead to identify steps necessary to correct data. Most importantly, the staff helps identify training needs and reports progress to the COC Board. Quarterly meetings are scheduled to make sure the COC is in full compliance with HUD requirements.

CAPNC staff is actively involved with the HMIS Coordinated Entry Process. Initially, our agency was one of two organizations who participated; however, over the last few years the process has been expanded to include Sheridan, Gillette, Sweetwater County, Recovery Wyoming, and the VA.

A key partnership we have in our community is with Wyoming Rescue Mission. In order to address the needs of the homeless we need to have access to them. Often, this population is hesitant to seek help. Once a week we send an outreach coordinator and a medical provider to see residents of the mission on site. This is to both treat immediate issues as well as begin building a relationship of trust allowing them to seek our services as they work to transition from the mission to the community. The goal is to assist them with their health issues, as well, as address employment, housing, mental health, and substance abuse obstacles. We also work closely with the Wyoming Food Bank. We have collaborated with them by providing funding to support their efforts. In addition to Wyoming Food Bank, we work with Poverty Resistance. They provide food support. Because protein is often an issue at our local pantries, we provide funding to Poverty Resistance with a focus on purchasing protein to support the health of low-income individuals in our community.

CAP-NC Outreach Team consists of two client advocates. Our team meets one (1) day per week near or at the Wyoming Rescue Mission, where homeless individuals congregate for meals. CAPNC meets the homeless in the Natrona County Library parking lot on Wednesday afternoons. Additionally, Lisa Scroggins, Executive Director of the Natrona County Library, has afforded CAPNC a dedicated conference room to meet and interview people living on the street. Poverty Resistance serves 200+ meals per day and outreach is conducted inside and, more specifically, outside where people gather. Many of Casper's homeless can be found outside of Salvation Army's building where we conduct our street outreach as well. Additionally, people struggling with homelessness are found at the bus station, in Washington and City parks in Casper, along the railroad tracks west of Casper, and behind abandon buildings in Casper.

## **D. Service Provision**

a. Alignment with PATH goals:

Street outreach and community outreach are conducted at least weekly. Outreach efforts are funded via the Emergency Solutions grant but are closely aligned with PATH. The VI SPDAT is utilized to identify adults who are literally homeless and those who are chronically homeless. Clients who are eligible for PATH are given top priority with regard to case management and other services offered by CAPNC. PATH personnel funds are expended only on PATH case management and essential grant management tasks such as reporting. Each individual's

situation is considered to determine what level of housing is required. PATH case management is utilized to quickly address the housing situation and help participants stay housed. PATH funds are limited for PATH approved housing costs, which, generally, are used for security deposits.

## b. Gaps that exist in the current service systems:

People struggling from mental illness are often unable to stay at local emergency homeless shelters due to behavior issues within the facility resulting from not having a prescribed mental health medication or from failing to regularly take prescribed medication. Individuals struggling with substance use issues in Natrona County can have similar issues, as they do not remain clean while staying at the emergency shelter, which results in being removed from the shelter. Depending on the severity of the issue, these individuals may be admitted to the local hospital, Wyoming Medical Center. Upon discharge from Wyoming Medical Center, it is often essential to refer clients immediately to an in-patient program. In-patient treatment programs traditionally have lengthy wait lists.

The lack of affordable and attainable mental health and substance use treatment services continue to hinder the well-being and recovery of many PATH participants. Many mental health centers have faced budget cuts, resulting in fewer and fewer available services, as well as cuts to Medicare and Medicaid Programs, which are utilized by the majority of the participants.

A shortage of affordable housing is a significant barrier, especially for those who suffer from mental health and substance abuse issues. Our typical PATH clients have sporadic employment history and therefore, do not have stable housing options. The best options are Permanent Supportive Housing program and HUD Section 8 vouchers.

c. A brief description of the current services available to clients who have both a SMI and SUD.

CWCC provides the most extensive therapeutic modalities to assist participants struggling with serious mental illness and substance use disorders. Additionally, Wyoming Behavioral Institute provides in-patient psychiatric care for the treatment of mental illness.

## d. PATH eligibility, enrollment, and documentation:

Engagement occurs with an interactive, purposeful, informal assessment to see if the person meets PATH eligibility. Enrollment occurs if the PATH eligible person agrees to enroll. Eligibility and enrollment are recorded in the HMIS Data Entry System. In order to receive services, individuals must be homeless or at imminent risk of homelessness. Additionally, the individual must have a mental illness or have a history of mental health issues. Individual can have a co-occurring substance use disorder. Individuals are enrolled in PATH when the PATH eligibility criteria are met and there is a mutual agreement that services will be provided.

We employ three options for establishing homeless status: (1) The homeless individual must obtain written documentation from a 3rd Party establishing their homeless status; (2) Intake worker observes homelessness, and (3) self-certification of homelessness.

## E. Data

Wyoming PATH providers use the HMIS PATH module. It is a requirement of all PATH providers to enter every PATH encounter within five business days and to enter all HMIS information with 100% accuracy and 100% completion.

CAPNC PATH staff members will use HMIS strictly in accordance with policies and procedures. Staff members attend annual security training in addition to the required general HMIS trainings. Every project report will be run on a monthly, quarterly and annual basis. Data will be entered in a timely manner. Data entered will accurately represent information on the clients being served.

If the need to train new staff does arise, CAPNC will ensure the new staff member(s) completes all necessary requirements to access HMIS, as well as complete basic competency training with the Institute for Community Alliance Staff.

First, CAPNC has developed a Housing First Program to permanently house chronically homeless individuals, who usually meet PATH eligibility. PATH clients are prioritized. This program is especially effective for PATH eligible clients, as the program includes intensive case management and support, such as weekly home visits, transportation assistance to Healthcare for the Homeless or other medical appointments, and transportation to food banks. Second, we collaborate with Casper Housing Authority to

assist PATH eligible client's access Section 8 vouchers. Once a client has a voucher, CAPNC uses other funding, such as Community Service Block Grant funds to pay the required deposit, which can often inhibit clients from using the Section 8 voucher. Third, CAPNC collaborates with several landlords within Natrona County who work directly with our agency. Outreach Program Manager and Housing First Program Manager conduct apartment walk-throughs with a checklist as they review and approve each unit. They also work with us to ensure the housing is affordable for PATH clients.

## G. Staff Information

#### I. Consumer Involvement

CAPNC is organized with a tri-partite board that is responsible for providing both financial and programmatic governance. As a tri-partite board, our member composition cannot be less than 1/3 of members from the consumer population. In our by-laws, those board members must be currently from the low-income community or have been from the low-income community. Additionally, they are elected to the board by a community wide election and only those who are from the low-income community can vote in the election. This process allows the low-income community as a whole assist the agency in determining who can best represent their experiences and needs as decisions on funding and programs are evaluated for our agency. These board members then provide the whole board feedback and guidance from the perspective of the consumer of human services targeted at individuals who are experiencing financial instability, housing and food insecurity, as well as mental health and substance abuse services. As this is a requirement in our by-laws, we will continue to utilize this type of consumer involvement.

The Red Feathered Eagle Vocational Rehabilitation services the Wind River Indian Reservation (WWIR) and surrounding communities of Fremont County, and portions of Hot Springs County. Our priorities focus on Native Americans with disabilities for gainful employment and to help Native Americans with disabilities lead more independent lives. The RFEVR provides community based services that encourage Spiritual, Emotional, Mental, and Physical growth and balance for individuals, families, and our community. Our services address mental health issues as they relate to disabilities as well as mental health within the Medicine Wheel approach to "walking in balance." We serve both individuals with mental health, physical disabilities, and cooccurring abuse disorders. We will work in collaboration with the Indian Health Services and the Behavioral Health Services.

By providing dedicated services the program contributes to values of individual resiliency and community vitality for generations of fulfilled people. These services include recovery supportive services through our program and referrals to resources with our community which culturally oriented and appropriate.

#### B. Collaboration with HUD Continuum of Care (CoC) Program

EST has not made these connections as new PATH service provider. With the help from the Wyoming Department of Health, Behavioral Health Division, and assistance from other PATH Sub-recipients, EST will be connected to Wyoming's Continuum of Care (COC) and Wyoming Homeless Collaborative (WHC).

RFEVR is a new PATH provider and is still new to the Wyoming's HUD CoC, the WHC. RFEVR will work collaboratively with nearby partners to maximize community resources. RFEVR will also work with other organizations conducting the annual HUD Homeless Point In Time count in Fremont and Hot Springs counties. Staff will participate in CoC meetings and Coordinated Entry phone calls which coordinate efforts between agencies statewide. We continue to work to familiarize the staff to the

RFEVR has collaborative efforts in place with all Shoshone Tribe programs: Department of Family Services, Temporary Assistance for Needy Families, Shoshone Housing, and within the Fremont County Court system as well as the newly formed Wind River Inter Tribal Wellness Court, and the Indian Health Services. The program has a close working relationship with Eastern Shoshone Recovery Program in assisting individuals with employment and housing barriers. The Program also works with both Eastern Shoshone and Northern Arapaho Housing programs. In addition, the program works closely providing outpatient treatment services to individuals sheltering in local shelters, transitional living facilities or sober living.

The RFEVR program work to build partnerships with First Stop, Wind River Cares Strengthening Families program and other county wide programs providing these types of services. Tribal Health Programs for the Shoshone & Arapaho Tribes split. Through the PATH Program and other collaborations, the program will be outreaching to homeless individuals within the boundaries of the Wind River Indian Reservation, also including Riverton City Park (Riverton, WY), as a community services project with our participants wishing to extend their service to others. This will be a weekly event led by our RFEVR staff and others wishing to provide their time and assistance to those homeless individuals. The outreach will consist of Talking Circles, smudging, a meal and assistance for those who are prepared to access community based services: treatment, social services, housing, family contact, etc. These efforts will be enhanced with the addition of PATH: people experiencing homeless who are eligible for PATH will be able to receive additional support and resources. PATH will provide the resources to move individuals, when they are ready, from the streets to safe shelter and homes.

The PATH Program will also provide SSI/SSDI Outreach, Access, and Recovery (SOAR), which is a program designed to increase access to Social Security Administration (SSA) disability benefits for eligible individuals who are experiencing or at risk of homelessness and have a mental illness, medical impairment, and/or a co-occurring substance use disorder.

Many people with disabilities who experience homelessness or are at risk of homelessness (e.g., those returning to the community from institutions such as jails, prisons, or hospitals) struggle to access the resources they need. Many suffer from disabling mental illnesses, co-occurring substance use, trauma, and medical issues that impact their ability to work. The path to recovery can be extraordinarily challenging when one is constantly struggling to meet basic needs. Having income and health care benefits is often a critical first step on the road to recovery. The services provided under the SOAR program will also help assist those eligible for services under the Social Security Administration's SSI/SSDI outreach with their path to recovery.

#### **D.** Service Provision

a. Alignment with PATH goals:

The RFEVR has provided services to the community on the Wind River Reservation for over 30 years. The services provided are an Outpatient program so case management is an integral entity of service delivery. Eastern Shoshone Recovery has been providing weekly Outreach to homeless in the Riverton City Park since 2011 for comfort support and advocacy services, RFEVR will continue these services.

In addition, as part of the case management services for individuals seeking services at RFEVR, having secure housing, employment and a support network are important for recovering individuals.

b. Gaps that exist in the current service systems:

One of the primary gaps in service systems here in Fremont County is affordable housing and/or safe sober housing. The individuals needing assistance in various areas mostly are able to receive some assistance; however due to high unemployment, high cost of living and limited affordable housing people struggle to maintain homes and often are forced to move back into multi-family housing.

A brief description of the current services available to clients who have both a SMI and SUD.

As part of the Case Management / Advocacy services the program initiates participant action with other community providers. We will utilize other resources and provide to participants these resources as well as employment information, if needed. The Case Manager will continue to gain ability to assist participants in applying to funding sources and/or resources for individuals with Serious Mental Illness.

d. PATH eligibility, enrollment, and documentation:

The Program will continue to determine PATH eligibility as demonstrated in the deliverables of PATH participation. The program will build an application packet with demographic information, and consents for individuals to sign and provider permission to contact other providers for documentation of SMH diagnosis or Co-Occurring diagnosis. Homelessness criteria is explained and qualified by self-report of status within guidelines.

Engagement occurs with an interactive, purposeful, informal assessment to see if the person meets PATH eligibility. Enrollment occurs if the PATH eligible person agrees to enroll. Eligibility and enrollment are recorded in the HMIS Data Entry System.

#### E. Data

Wyoming PATH providers use the HMIS PATH module. It is a requirement of all PATH providers to enter every PATH encounter within five business days and to enter all HMIS information with 100% accuracy and 100% completion.

RFEVR PATH staff members will have access to HMIS to ensure the highest quality of compliance with meeting the time requirement for data entry and to guarantee accuracy of the data entered into the system. PATH staff will attend trainings relative to HMIS to ensure the most current policies and procedures are being followed correctly. Staff will complete all necessary requirements to access HMIS as well as complete basic competency training with the Institute for Community Alliance Staff. Eligibility and enrollment are recorded in the HMIS Data Entry System. RFEVR staff will continue training within the HMIS system.

#### F. Housing

RFEVR will utilize the resources within the community for housing of participants: Temporary, if

EST has not made these connections as new PATH service provider. With the help from the Wyoming Department of Health, Behavioral Health Division, and assistance from other PATH Subrecipients, EST be connected to Wyoming's Continuum of Care (COC) and Wyoming Homeless Collaborative (WHC).

ESRP is a new PATH provider and is still new to the Wyoming's HUD CoC, the WHC. ESRP will work collaboratively with nearby partners to maximize community resources. ESRP will also work with other organizations conducting the annual HUD Homeless Point In Time count in Fremont and Hot Springs counties. Staff will participate in CoC meetings and Coordinated Entry phone calls which coordinate efforts between agencies statewide. We continue to work to familiarize the staff to the resources available at the county, state, and federal levels.

the Fremont County Court system, as well as the newly formed Wind River Inter Tribal Wellness Court. The program has a close working relationship with Red Feathered Vocational Rehabilitation in assisting individuals with employment and housing barriers. The Program also works with both Eastern Shoshone and Northern Arapaho Housing programs. In addition, the program works closely providing outpatient treatment services to individuals sheltering in local shelters, transitional living facilities or sober living.

The ESRP program has worked with First Stop, Wind River Cares Strengthening Families program and other county wide programs providing these types of services. We work with the Eagles Hope and Center of Hope on a referral basis as well as local church resources, food banks in both Riverton and Lander to refer individuals to those resources as well.

The ESRP has provided outreach programming as a part of the services since the previously combined Tribal Health Programs for the Shoshone & Arapaho Tribes split. The program began an outreach to homeless individuals in Riverton City Park (Riverton, WY) in 2011, as a community services project with our participants wishing to extend their service to others. This is a weekly event led by our Peer Specialist and others wishing to provide their time and assistance to those homeless individuals. The outreach consists of Talking Circle, smudging, a meal and assistance for those who are prepared to access community based services: treatment, social services, housing, family contact, etc. These efforts will be enhanced with the addition of PATH: people experiencing homeless who are eligible for PATH will be able to receive additional support and resources. PATH will provide the resources to move individuals, when they are ready, from the streets to safe shelter and homes.

#### **D. Service Provision**

a. Alignment with PATH goals:

The ESRP has provided services to the community on the Wind River Reservation for over 21 years and prior to that 25 + years as a Joint Tribal Program. The services provided are an Outpatient program so case management is an integral entity of service delivery. We have been providing weekly Outreach to homeless in the Riverton City Park since 2011 for comfort support and advocacy services.

In addition, as part of the case management services for individuals seeking services at ESRP housing, employment and a recovery support network are important for those individuals.

One of the primary gaps in service systems here in Fremont County is affordable housing and/or safe sober housing. The individuals needing assistance in various areas mostly are able to receive some assistance; however due to high unemployment, high cost of living and limited affordable housing people struggle to maintain homes and often are forced to move back into multi-family housing.

c. A brief description of the current services available to clients who have both a SMI and SUD.

As part of the Case Management / Advocacy services the program initiates participant action with other community providers. We will utilize other resources and provide to participants these resources as well as employment information, if needed. The Case Manager will continue to gain ability to assist participants in applying to funding sources and/or resources for individuals with Serious Mental Illness.

d. PATH eligibility, enrollment, and documentation:

The Program will continue to determine PATH eligibility as demonstrated in the past years of PATH participation. The program has application packet with demographic information, and consents for individuals to sign and provider permission to contact other providers for documentation of SMH diagnosis or Co-Occurring diagnosis. Homelessness criteria is explained and qualified by self-report of status within guidelines.

Engagement occurs with an interactive, purposeful, informal assessment to see if the person meets PATH eligibility. Enrollment occurs if the PATH eligible person agrees to enroll. Eligibility and enrollment are recorded in the HMIS Data Entry System.

#### E. Data

Wyoming PATH providers use the HMIS PATH module. It is a requirement of all PATH providers to enter every PATH encounter within five business days and to enter all HMIS information with 100% accuracy and 100% completion.

ESRP PATH staff members will have access to HMIS to ensure the highest quality of compliance with meeting the time requirement for data entry and to guarantee accuracy of the data entered into the system. PATH staff will attend trainings relative to HMIS to ensure the most current policies and procedures are being followed correctly. Staff will complete all necessary requirements to access HMIS as well as complete basic competency training with the Institute for Community Alliance Staff. Eligibility and enrollment are recorded in the HMIS Data Entry System. ESRP will continue training within the HMIS system.

ESRP will utilize the resources within the community for housing of participants: Temporary, if immediate need, as well as sober living and transitional housing opportunities for recovery support. The ESRP will also utilize existing housing opportunities: low income housing, Tribal Housing and rental housing for individuals. Thirdly, within the grant the opportunity for individuals to obtain assistance in repairs in their existing home so as not to become homeless due to inadequate structure.

#### **G.** Staff Information

Wyoming PATH utilizes the National Standards for Culturally and Linguistically Appropriate Services (CLAS) in Health and Health Care.

ESRP staff for the PATH program will be of Native American descent. ESR utilizes the Medicine Wheel recovery approach, Talking Circle, smudging and other historically cultural practices for an understanding based in the cultural values: Relationship, Reciprocity, Respect and Responsibility. These cultural values are interwoven in the programming and interaction between staff, participants, and community. Programming at ESRP is consistent for the people who live in the WWIR.

ESRP currently employs four Wyoming certified peer specialists who have taken a primary role in addressing homelessness for our People. One of these peer specialists has completed the Peer Specialist in the Criminal Justice System training which will complement the PATH grant. The intent is to continue a focus on recovery and recovery supports via the PATH grant.

#### B. Collaboration with HUD Continuum of Care (CoC) Program

Both PATH case managers attended the annual in-person Continuum of Care (CoC) meeting in Casper on June 26, 2019 and will attend an upcoming meeting on June 17, 2020. Additionally, PATH case managers attended two Zoom CoC meetings September 10, 2019 and February 10, 2019. Dawn Cranmore attends the Data Quality Committee monthly meetings with Bobbie Neilson from HMIS and other community partners throughout Wyoming. This committee monitors data to make sure HUD regulations are being met in HMIS.

RW plans to research funding and resource opportunities through Community Service Block Grant (CSBG) and Community Development Block Grant (CDBG). Emergency Solutions Grant Program (ESG) funding is not a viable option for our organization due to the 100% match requirement. Previous attempts to obtain housing vouchers from Cheyenne Housing Authority were not successful. However, a collaboration did result as an outcome of that interaction.

**Primary Health** – RW partners with Heathworks, an income-based primary healthcare service and Federal Qualified Health Centers (FQHC) by providing referrals and transportation to the clinic. Community Action of Laramie County's Crossroads Clinic and mobile clinic also provides primary care. RW also provides referrals for services through the Behavioral Health Clinic at Cheyenne Regional Medical Center.

Mental Health and SUD Services – Partnerships for these services include referrals and warm hand-offs to Peak Wellness Center, Pathfinder Treatment Services, and numerous private counseling offices.

Transportation - RW works with Cheyenne Transit Program to provide local transportation.

In the past, PATH staff was unsuccessful in obtaining housing vouchers to use for the PATH Program.

Both PATH case managers attended the annual in-person CoC meeting in Casper on June 26, 2019 and will attend an upcoming meeting on June 17, 2020. Additionally, PATH case managers attended two Zoom CoC meetings September 10, 2019 and February 10, 2019. Dawn Cranmore attends the Data Quality Committee monthly meetings with Bobbie Neilson from HMIS and other community partners throughout Wyoming. This committee monitors data to make sure HUD regulations are being met in HMIS.

The Y.E.S. House works closely with Council of Community Services which provides HUD Section 8 housing, runs the soup kitchen and emergency shelter. The agency also works closely with GARF (Gillette Abuse Refuge Foundation), a domestic violence shelter, and reaches out to the domestic violence victims who are literally homeless.

The Council of Community Services and the Y.E.S. House work closely to coordinate their efforts to help homeless young people reach stability and build a constructive life. These are the only two entities in Campbell County that receive federal funds to serve homeless people. Both organizations' representatives serve on the local CARE Board (board oversees the CSBG funds); are recipients of the ESG funding, and provide their input on trends of homelessness, and what this vulnerable population needs. Due to the collaborative efforts in the community, the Behavioral Health Division under the local hospital were able to open a psychiatric unit in 2017. This effort has dramatically reduced the number of detained individuals with serious mental health issues.

The Y.E.S. House works closely in collaboration with courts, the local detention center, Campbell County Attorney's office, housing programs, DVR, Workforce Center, mental health/substance abuse providers, and health care providers in-order-to make sure the PATH young adults under Title 25 and or with criminal histories receive the services they need. The Attorney's Office is aware of the Y.E.S. House's services and contacts us when there is a young adult that needs our services. Both entities work together to find alternative living arrangements in order to prevent detaining a person with mental health issues. Our community mental health providers also work closely with the Y.E.S. House to ensure that high-risk individuals receive proper treatment and involuntary hospitalizations are minimized.

Case managers frequently visit our local detention center to build relationships with clients as they are reentering the community as well as when they have further incarceration after joining the Young people embrace this level of support. The detention staff work closely with the PATH staff to ensure that those vulnerable youth have housing options and support upon their discharge to reduce re-entry. PATH staff also routinely visit Wyoming Boys School and Wyoming Girls School, as these youth exiting detention at age 18 experience homelessness at a rate of 60% in the first two years after their release. Detention Center's staff know to call Y.E.S. House staff, and we work on finding housing options for those young adults that have nowhere to go upon leaving the centers.

The majority of PATH eligible young people with criminal backgrounds need a broad range of services in order to thrive in society. Staff develop an individual case plan for each person. Case plans set goals and specific steps to achieve them. These are individualized plans based on clients' needs for their future. Path young people are provided with Service-Learning opportunities monthly so they learn the importance of serving others and giving back to their community. Obtaining employment and stable housing are most often goals for the PATH clients. Life skills groups provide support and education which help clients acclimate to society, and provide a deeper sense of community with other individuals in similar situations while building a support network. Clients with criminal histories feel integrated into a social setting where there is no judgment, and only support and skill building.

Sixty-five percent (65%) of clients that PATH services have had a juvenile justice or adult justice system involvement in 2020; 80% of them are living independently in their own place, working or going to school.

The strong partnership that has developed among collaborative entities that serve young people is the key to the success of our outreach. In order to ensure that we reach out to the majority of young people that need our services, program staff connect weekly with the Campbell County School District, Gillette Abuse Refuge Foundation (domestic violence shelter), Gillette Police Department, Campbell County Health, a McKinney-Vento liaison, Workforce Center, and Juvenile Detention Center to make sure that services are offered to young people that not only

seek services through the Y.E.S. House, but through other agencies, associations, peer groups, etc.

The following outreach strategies are utilized by PATH case managers in order to ensure that young people that need the PATH grant assistance are reached: social media such as Facebook, word-of-mouth, public presentations and distribution of informational cards in local businesses, churches and clubs, and participation in Point-In-Time count. The Y.E.S. House has found that "street-outreach" is effective in connecting with young people and disseminating information that they can take to their friends and peer groups. Additionally, the program's brochures, flyers, information on the Y.E.S. House's website further enhance our outreach efforts. Every year, the Y.E.S House participates in community outreach events and fairs where we exhibit our services. Furthermore, the involvement of alumni and Youth Action Board members in the outreach process is another important contributor in making outreach successful.

The goal for the PATH outreach efforts for 2020-2021 year is fifty (50). As of September 2019- March 2020, the staff outreached to thirty-three (33) homeless young people. We are on target.

#### **D. Service Provision**

#### a. Alignment with PATH goals:

The Y.E.S. House focuses its outreach and case management on young people aged 18-24 who are literally homeless, chronically homeless, and have a serious mental illness. By working with homeless young people for four decades, the Y.E.S. House has found that certain approaches work better than others. For example, street-outreach strategies are effective in connecting with young people and disseminating information that they can take to their friends and peer groups. Weekly case managers conduct street-outreach by going in pairs to locations where young people are gathering. The case managers talk to young people, give them backpacks that contain blankets, hygiene items, socks, protein bars, contact cards, and hotline information and talk to them about services.

Intensive case management is provided based on the needs of every young person. The Y.E.S. House case managers work with young people to connect them to services and resources. If they are in need of counseling, substance use intervention, or treatment services, the program either provides such services (Y.E.S. House employs eight (8) mental health/addiction counselors) or refers young people to other providers.

The Y.E.S. House owns OUR (Opportunity Understanding Responsibility) House that is designated to provide permanent housing to young people. The agency also partners

with apartment complexes to provide permanent housing to young people that seek more independence and a place of their own.

The PATH case managers work with young people to help them to identify career barriers and develop a plan for overcoming those barriers. The Y.E.S. House offers apprenticeship/on-the job training positions at the agency for young people to build employment skills, their resume and experience success of being employed. The agency partners with the state employment services and private businesses to assist young people with career exploration, internships, vocational training, job placement and retention. The partnerships with the Workforce Center and Department of Vocational Rehabilitation has been beneficial to the clients in utilizing services and programs under the Workforce Innovation and Opportunity Act as well as reducing barriers for youth with significant mental illnesses and other barriers to obtaining employment. Youth are learning computer skills, participating in mock interviews, resume writing classes and obtaining a GED/HiSet.

The Y.E.S. House works with young people to obtain a high school diploma, GED/Hiset and provides preparation for post-secondary training and education. To encourage program graduates to pursue post-secondary or vocational education, the Y.E.S. House offers a scholarship program to pay for their tuition, books, computers, notebooks, etc. Case managers are trained in the intensive case management and use evidence-based practices, such as Positive Youth Development and Motivational Interviewing. The team works with the youth to help identify support networks and grow them within the community through connections. This is an essential foundation for clients in order to obtain and sustain their housing opportunities long-term. Case managers teach independent living weekly sessions to assist young people with building self-sustaining life skills.

#### b. Gaps that exist in the current service systems:

The agency's biggest challenge continues to be finding affordable, permanent housing for Path eligible young people if they choose the option of permanent residency outside the Y.E.S. House OUR Home. Average monthly rent in Gillette is \$771 plus per one bedroom. The housing issue is ongoing, and the staff continually try to accommodate the needs of clients. Many resources are required to help clients out with high rent, deposits, basic essentials, and utility bills.

Another gap that people who are experiencing homelessness face in Campbell County is the lack of access to the reliable public transit system. The only form of public transportation in Gillette is taxi and Uber. In order to meet transportation needs of clients, the Y.E.S. House has purchased two vehicles for PATH staff to use to transport clients. Local businesses also donate bicycles for clients to use.

The program also provides taxi punch cards that the clients can earn by making progress towards their PATH transition goals.

The third gap has to do with the make-up of Gillette. It is an expensive community to live in and \$8 per hour would not pay monthly bills in this area. Most of the clients that the Y.E.S. House works with have very limited employment skills that would qualify for jobs that pay \$15 per hour. This is why the Y.E.S. House offers an apprenticeship/on-the-job training program in order to help young people build employment skills and their resume.

c. A brief description of the current services available to clients who have both a SMI and SUD.

Young people with co-occurring disorders have access to the Women's Resource Center that helps women with unexpected pregnancies to gain support and resources in order to take care of themselves and their baby. The Council of Community Services provides food, shelter, and transitional and permanent housing options to eligible individuals. Campbell County Heath provides psychiatric units, physiological and psychiatric assessments and counseling. The Y.E.S. House also works closely with GARF (Gillette Abuse Refuge Foundation), a domestic violence shelter, and reaches out to the domestic violence victims who are literally homeless. The Y.E.S. House works closely with the local hospital's behavioral health department and private counseling firms to offer additional services.

d. PATH eligibility, enrollment, and documentation:

The Y.E.S. House uses the TAY-VISPDAT assessment to assess the risk of the youth experiencing homelessness. In addition to this, medical documentation serves as verification. This is provided after screening, but before to PATH enrollment, to ensure eligibility based on SMI.

#### E. Data

Wyoming PATH providers use the HMIS PATH module. It is a requirement of all PATH providers to enter every PATH encounter within five business days and to enter all HMIS information with 100% accuracy and 100% completion.

Wyoming PATH is fully utilizing HMIS for PATH services. The Y.E.S. House holds six HMIS licenses and utilizes the system to report on services/clients served through the PATH funding. Four staff are trained in HMIS, and the agency is committed to continuing to train new staff when they come on board. An annual refresher HMIS training is open to all PATH staff. PATH staff are required to enter client's information within five days of each encounter

#### I. Consumer Involvement

The goal was to continue engaging young people in the Youth Action Board and promote involvement in WY CoC. In 2020, six (6) PATH clients were engaged in the Youth Action Board. Youth developed a Coordinated Community Plan to end youth homelessness in the northeast Wyoming region. Some of the strategies they identified are in the process of being implemented. For example, one of the strategies is to develop apprenticeship opportunities that are meaningful to them. The Y.E.S. House is partnering with the Workforce Center and a faith-based community to set up an apprenticeship program that young people identified. Another strategy is to train employers in Trauma-Informed Care and Adverse Childhood Experiences (ACEs) so that employers have a better understanding of struggles that young people are faced with on the daily basis. Currently, a young adult is in the process of submitting her application to serve on the WY CoC Board.

A State PATH RFA was distributed in April 2020, utilizing a statewide competitive grant process. Notification was given to all previous providers, including the Eastern Shoshone Recovery Program (ESRP). Notice was sent to a person inquiring about the services and was posted on the Division web page.

The Behavioral Health Division (Division) received five (5) PATH application, all of which were from previous PATH providers. All five (5) providers have experience in providing services to persons experiencing homelessness and who have a serious mental illness or co-occurring substance use disorder. Applications were also received from the ESRP.

These providers represent Wyoming's five largest counties (about fifty-three (53%) of the State's population). The combined applications report numbers that demonstrate their commitment to outreach and enrolling persons who are homeless and who have a serious mental illness or co-occurring substance use disorder.

The Division proposes to fund five (5) providers with PATH funds. MHBG funds, totaling \$100,000 over two years, to help support mental health services and case management services. ESRP serves tribal members who live near or on the Wind River Indian Reservation. The PATH funds will be distributed among all five (5) agencies, three (3) applied for small population coverage and two (2) applied for large population coverage.

It should be noted, due to State budget cuts there has been a removal of the State General Funds to each of these provider's contracts. The overall amount removed totals fifty thousand dollars (\$50,000.00), meaning ten thousand dollars (\$10,000.00) has been removed from each contract at the start of the next contract period (September 1, 2021 – August 31, 2022). State General Funds are no longer available for the PATH Program, at this time.

A State PATH Request For Application was distributed in April 2020, using a statewide competitive grant process. The notification was provided to all previous Subrecipients, including the Eastern Shoshone Recovery Program (ESRP). Notice was sent to an additional individual inquiring about the services. The notice was posted on the Division web page.

The Wyoming Department of Health, Behavioral Health Division (Division) received five (5) PATH applications, all of which were from previous PATH Subrecipients. All five (5) Subrecipients have familiarity with providing services to individuals experiencing homelessness and who have a serious mental illness or co-occurring substance use disorder.

Applicant Subrecipients represent Wyoming's five (5) largest counties (about fifty-three percent (53%) of the State's population). #### **K.** Other Designated Funding

The Mental Health Block Grant (MHBG) funding is used to support five (5) of the PATH Housing First projects. Each PATH provider will receive MHBG funds in the amount of ten thousand dollars (\$10,000.00) used for PATH Case Management services and mental health-related services.

Due to the Coronavirus 2019 (COVID-19) impacts, including reduced gas, oil, and coal production, available State General Funds (SGF) will be greatly reduced in the coming fiscal year. Therefore, the PATH Program will not be able to allocate the planned supplemental SGF in the upcoming contracts starting September 1, 2021.

The Behavioral Health Division (Division) supports the statewide SSI/SSDI Outreach, Access, and Recovery (SOAR) initiative. The Division has an internal SOAR specialist Subrecipients may reach out to. Four (4) of the five (5) local PATH Subrecipients have at least one (1) SOAR trained staff member, and two (2) of those PATH Subrecipients have staff who have completed the SOAR-LA.

The Division plans to provide Eastern Shoshone Recovery Program (ESRP) technical assistance funds to complete SOAR training. One challenge ESRP has identified is the lack of funding provided for the time and effort to complete SOAR training. Their efforts focus on outreach and other payable services. When submitting their IUP Budget, training for SOAR was not included. The Division also provided a SOAR contact person for the provider to reach out to if needed, along with information on how to find and complete the training.

The Division was granted nineteen thousand, one hundred and seventy-six dollars (\$19,176.00) in technical assistance funds for the PATH Program. These funds will be used for technical assistance and training activities related to serving the PATH eligible homeless persons who are: 1) suffering from serious mental illness or suffering from serious mental illness and a substance use disorder, and 2) homeless or at imminent risk of becoming homeless.

Seven thousand, four hundred and ninety-five dollars (\$7,495.00) in technical assistance funds have been obligated to five (5) current PATH Subrecipients. Also, seven (7) Mental Health and Substance Abuse Centers currently contracting with the Division are receiving an allocation totaling ten thousand, four hundred and ninety-three dollars (\$10,493.00) for time and effort in obtaining and completing SOAR training.

The remaining one thousand, one hundred and eighty-eight dollars (\$1,188.00) will go to ESRP for SOAR training in the next round of contracts, starting September 1, 2021. Funds will be obligated in our Wyoming Online Fiscal System before the September 1, 2021 start date.

The Division also received COVID-19 Relief Funds for both the Community Mental Health and Substance Abuse Prevention and Treatment (SAPT) Block Grants (BG). Wyoming is requesting approval to use the SAPT BG COVID Relief Funds for targeted housing costs through the global revision request. Currently, one hundred thousand dollars (\$100,000.00) is allocated for assistance in covering Housing First support that may be reduced due to Wyoming budget constraints. Funds

The Wyoming Department of Health, Behavioral Health Division (Division) is required to provide this dissemination notice of Charitable Choice to your organization, as your organization is a Subrecipient of Substance Abuse Prevention and Treatment Block Grant funds through a current contract with the Division.
