





Electronic Disease Notification (EDN)

The EDN system notifies the WDH TB Program when an immigrant to the United States is in need of TB follow-up upon arrival to the United States (Class B1). These will be individuals who were not suspected of having active TB when they left the country of origin. Those suspected of having active TB must complete TB treatment prior to departing their country of origin. When CDU receive a case, per federal guidelines, the case is referred to the county Public Health office in the county the immigrant reports they are residing.

In total, CDU has 30 days from the time the case is received to report back to CDC; the Public Health office has about 21 days to see the patient and complete the worksheet. CDU then has about 7 days to review and complete reporting in the national system. Offices can invoice CDU \$50 per EDN client.

## **340B and Wyoming Public Health Offices**



All Wyoming public health offices have 340B designation under CDU which allows them to obtain PPD serum, birth control, and STD meds at 340B pricing. In some cases the 340B meds are provided directly through CDU and in some cases offices order these items on their own. During annual 340B recertification in April/May CDU must attest that each 340B location is compliant with 340B rules which includes reporting. Locations that are not compliant with reporting will not be recertified and no longer able to order 340B medications and supplies through the CDU. Below is the reporting requirements:

- Dispensed and or None Given reporting for 340B STD, 340B TB, and/or EPT STD is due by the 5th of every month.
- None given reporting can be completed between the last day of the month through the 5th of the following month.
