MCH Quarterly Highlight: Lead Poisoning Prevention & Mental Health Care Access Grants

Last year, the MCH Unit applied for, and received, two new grants to expand services for children.

The first is the Centers for Disease Control and Prevention (CDC) Childhood Lead Poisoning Prevention and Surveillance of Blood Lead Levels in Children grant. Funding from this grant will be used to build state capacity to support strategies for childhood lead poisoning prevention and surveillance. The State of Wyoming does not currently have a dedicated lead program, so this funding is invaluable for the health of Wyoming children. The Public Health Division is seeking a Blood Lead Prevention Program Manager and Epidemiologist to support the activities of this grant. (Interested in this position? Apply here!)

The second is the Pediatric Mental Health Care Access (PMHCA) grant from the Health Resources and Services Administration. This project will support the use of telehealth in primary care to improve access to mental health care for children and adolescents. Stay tuned for more updates on the progress of these projects!

#### **MCH Program Updates**

Newborn Screening & Genetics Program

On January 4, 2022, the Newborn Screening Advisory Committee voted to add X-linked Adrenoleukodystrophy (X-ALD), Pompe Disease, and Mucopolysaccharidosis I (MPS I) to the Wyoming panel. Testing is expected to begin in the Summer/Fall of 2022.



The Wyoming Genetic Clinics will continue in 2022, with sites in Casper, Cheyenne and Riverton. The clinic schedule can be found here.

Beginning April 1, 2022 birthing hospitals will no longer be de-identified on the Newborn Screening Report Card Dashboard found here.

#### <u>MCH Epidemiology and Wyoming Pregnancy Risk Assessment Monitoring</u> <u>System (PRAMS) Programs</u>

The MCH Epidemiology Wyoming PRAMS Program has added 2020 data to it'sWY PRAMS Dashboard. The Adolescent Suicide Data Brief has aslo been posted to the Wyoming MCH Priority Data.
