 - Providing assistance in obtaining and coordinating social and maintenance services for the eligible homeless individuals, including services relating to daily living activities, personal financial planning, transportation services, and habilitation and rehabilitation services, prevocational and vocational services, and housing;
 - Providing assistance to the eligible homeless individual in obtaining income support services, including housing assistance, food stamps, and supplemental security income benefits;
 - · Referring the eligible homeless individual for such other services as may be appropriate; and
 - Providing representative payee services in accordance with Section 1631(a) (2) of the Social Security Act if the eligible homeless individual is receiving aid under Title XVI of such act and if the applicant is designated by the Secretary to provide such services.
- · Supportive and supervisory services in residential settings;
- · Referrals for primary health services, job training, education services and relevant housing services;
- Housing services [subject to Section 522(h)(1)] including:
 - Minor renovation, expansion, and repair of housing;
 - Planning of housing;
 - · Technical assistance in applying for housing assistance;
 - · Improving the coordination of housing services;
 - Security deposits;
 - The costs associated with matching eligible homeless individuals with appropriate housing situations;

Section 522(c). The State will make grants pursuant to Section 522(a) only to entities that have the capacity to provide, directly through arrangements, the services specified in Section 522(b), including coordinating the provision of services in order to meet the needs of eligible homeless individuals who are both mentally ill and suffering from a substance abuse disorder.

Section 522(d). In making grants to entities pursuant to Section 522(a), the State will give special consideration to entities with a demonstrated effectiveness in serving homeless veterans.

Section 522(e). The state agrees that grants pursuant to Section 522(a) will not be made to any entity that:

Mental health and substance use disorder treatment and recovery services are available through PATH case managers who facilitate entry into low or no-cost treatment services.

The Division and the PATH Subrecipient providers continue to champion the expansion of Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI) Outreach, Access, and Recovery (SOAR) including efforts to adopt recommendations from the SOAR Leadership Academy (SOAR-LA). Alliance with Wyoming's Housing and Urban Development (HUD), HUD Continuum of Care (CoC), and the Wyoming Homeless Collaborative (WHC), allows for continued improvement of the utilization of the Homeless Management Information System (HMIS), completion of the annual Point in Time (PIT) count and PATH's participation in a coordinated entry, which is designed to prioritize the people served through PATH. Each PATH provider is encouraged to seek collaboration with CoC, HUD, WHC, and HMIS. State-level staff diligently provide programmatic and fiscal guidance and oversight to ensure outputs and outcomes are achieved while adhering to rules and regulations.

This memo is in reference as to how the Wyoming Department of Health recovers indirect costs related to federal grants. The process is clarified below.

The U. S. Department of Health and Human Services approved our plan for recovering indirect costs as they relate to federal grants as of August 29, 2018. Our plan was submitted on an actual cost basis. This means Fiscal Services will calculate the actual costs that are considered indirect costs by definition and charge those costs to each grant based upon the grant expenditures. Fiscal Services performs this process quarterly.

For State Fiscal Year 2022, we estimate the actual percentage of indirect costs will again be 21.5%. For grant budgeting purposes, you should calculate indirect costs at 21.5%. As a guideline, you should calculate the indirect costs on the budget amounts for 100, 200, and 400 series expenditures, less equipment purchases charged to 0240-0259.

Please note some grants limit the percentage that can be collected for indirect costs. If your grant has such a restriction, use the grant specific percentage in preparing the budget for the grant application.

In order to receive funds, PATH Subrecipients provide a monthly invoice with an approved workbook for reimbursement costs for completed eligible activities.

Wyoming utilizes a Housing First approach to house individuals in community settings as quickly as possible. Then, Subrecipients provide services, as needed, to the individual being served. Housing is not contingent upon receiving PATH services. However, case management services are offered as a way to establish long-term resources. Individuals are not required to be in treatment in order to keep their housing or receive PATH services.

PATH Subrecipients actively participate with the Wyoming Homeless Collaborative in the Point in Time Count (PIT) to conduct the annual count of homeless people in a single night, as required by the U.S. Department of Housing and Urban Development (HUD) for Continuum of Care (CoC). These collaborations coordinate community resources to maximize the opportunity for individuals to stay housed.

PATH Subrecipients work with their local mental health and substance abuse treatment provider, who may also be a subrecipient of Community Mental Health and Substance Abuse Prevention and Treatment Block Grant (Block Grants). Subrecipient treatment providers utilize business and clinical practices supporting high-quality and cost-effective services. PATH participants may receive these services from very low cost to no cost. Funds from the Block Grants provide a large portion of treatment funding as long as the individual meets eligibility requirements. Output and outcome trends, including housing and employment status, can impact funding, programming decisions, and system of care planning.

Wyoming has an expectation of PATH Subrecipients to serve veterans experiencing homelessness or at an imminent risk of homelessness. Variance to this expectation is Grant Subrecipient, Youth Emergency Services, Inc., whose general services are reserved for the potentially high risk youth and adolescents under the age of 18 population.

Other Wyoming PATH Subrecipients continue to prioritize the needs of veterans experiencing homelessness. Local PATH partnerships collaborate with veteran's hospitals, outpatient and outreach centers, benefit centers including housing supports, the Healthcare for Homeless Veterans program, Supportive Services for Veteran's Families program, and Vet Centers.

The goal to identify veterans who are experiencing homelessness and quickly unite these individuals with services to assist them in becoming and staying housed is continuous. PATH Case Management is offered to veterans and will be provided to veteran participants as long as necessary.

Through Wyoming's PATH Request for Applications (RFA) process, street outreach and case management are identified as core functions that must be provided within each Subrecipient's PATH program. Street outreach and case management are included as deliverables within each provider Contract and statement of work (SOW).

Outreach is a service required by Subrecipient providers to travel and visit individuals who are literally homeless and those experiencing homelessness in frequent homeless areas. Each Subrecipient has set targets for the number of persons to be outreached. Outreach personnel utilize tools of engagement to build the trust and rapport of individuals who are homeless, in hopes of leading those individuals to assessment opportunities, including assessing needs for mental health, substance use, and other health services.

Once an individual's eligibility for PATH-funded services is established and the individual enrolls in a Subrecipient PATH program, case management services are rendered. Target numbers for PATH enrolled and housed individuals are also set in each provider Contract and SOW. PATH service priority is reserved for individuals who have histories of chronic homelessness and those in situations placing them at increased vulnerability. Case management services play an integral part in assisting the individual to stay connected to community services that enhance recovery outcomes.

The PATH Grant and the corresponding goals align with Wyoming's focus on providing access to mental health and substance abuse disorder services to individuals with the most critical needs. Wyoming comprehensive mental health services plans have a shared mission to be responsive to the behavioral health needs of Wyoming residents by developing and overseeing a quality integrated continuum of care that is customer-focused, collaborative, evidenced-based and outcomes driven. PATH services help address a gap in the continuum of care by identifying potential participants who may not otherwise take part in other Wyoming mental health and substance use services through outreach.

PATH Subrecipients partner closely with publicly-funded mental health and substance use treatment providers. Output and outcome trends, including housing and employment status, can impact funding, programming decisions, and system of care planning. Treatment providers receive the Community Mental Health and/or the Substance Abuse Prevention and Treatment Block Grant; where the treatment providers utilize business and clinical practices supporting high-quality and cost-effective services. PATH participants may receive treatment services for little or no cost.



The Wyoming Department of Health, Behavioral Health Division (Division) provides programmatic and fiscal oversight of the PATH Subrecipients through virtual site reviews, desk audits, and a review of their monthly reporting. At a minimum, annual, virtual site reviews are conducted by the State PATH Program Manager who utilizes the onsite review material provided by the Wyoming Department of Health Grants Policies and Procedures Section, along with previous Division materials. Grantees are provided timely feedback, and are provided time to make corrections, if necessary.

The Subrecipient's monthly invoices and reports break out the numbers served in outreach and provided PATH Case management services. The monthly invoices and reports also include the number of individuals housed and continue to be housed, utilization of the Supplemental Security Income (SSI) / Social Security Disability Insurance (SSDI) Outreach, Access, and Recovery (SOAR) for continued financial support, and other input and outcome measures. Contract invoices and fiscal documents track fiscal information, including the 3:1 local match, the twenty percent (20%) maximum for housing, administrative costs, and the amount of funds expended.

Virtual site reviews and desk audits focus on programmatic issues including short-term and longterm planning, problem-solving, outreach issues, use of best practices, examples from other communities, and training needs. Virtual site reviews include a review of contract compliance, consistency with PATH rules and regulations, staff interviews, meetings with consumers, fiscal review, and participant record reviews. The participant records review includes a review of the case management details, individualized plans, and financial records for each individual participant. Virtual site reviews are also used to identify possible technical assistance needs, including problem-solving for systemic issues. Technical assistance from the Division is available throughout the contract cycle.

The State PATH Program Manager is responsible for ensuring PATH services are integrated with other services funded by the Division and provide a seamless continuum of care.

The Division utilizes a culture of performance management. Performance improvement for Subrecipient providers is advanced through continuous monitoring of data and other information received from providers and the development of performance improvement plans, as necessary, to ensure contract deliverables and program objectives are met.

H. Selection of PATH Local-Area Providers:

Describe the method(s) used to allocate PATH funds to areas and providers with the greatest number of individuals who experience homelessness with serious mental illnesses or cooccurring substance use disorders (i.e., through annual competitions, distribution by formula, data driven or other means).

The method to allocate PATH funds is through an annual, competitive Request for Application (RFA) process, disseminated by the Wyoming Department of Health, Behavioral Health Division (Division). The RFA was distributed to all previous Subrecipients and a notice was sent to additional individuals inquiring about the funding opportunity. The notice was also posted on the Division's web page.

The allocation within the RFA is split between Large and Small Population classifications. Total amounts are based on funding two (2) Large counties and three (3) Small counties, for a total of five (5) programs possible. Due to Wyoming's low population overall, of the twenty-three (23) counties in Wyoming, the two (2) largest populated counties contain over 70,000 individuals per county, and the remaining twenty-one (21) counties contain less than 70,000 individuals per county. If funds are available after receiving and reviewing RFA applications, a redistribution of funds and determination formula will be employed. Determination of how much each Subrecipient will be awarded will be based on the PATH applicant's abilities to meet the local match requirement. If further funds remain, the Division will open the RFA process again for one (1) to two (2) additional providers.

For the FFY23 cycle, the Division received four (4) PATH applications. All four (4) applications were previous Subrecipients who have familiarity with providing services to individuals experiencing homelessness and who have a serious mental illness or co-occurring substance use disorder. The Division proposes funding the four (4) applicants with PATH funds, through Substance Abuse Prevention and Treatment Block Grant funds, and COVID-19 supplemental funding for strict housing. PATH funds will be distributed among the four (4) Subrecipients, three (3) for Small Population coverage and one (1) for Large Population coverage.

State General Funds and Mental Health Block Grant funds will no longer be utilized to supplement PATH-related activities due to statewide budget cuts.

Wyoming's population of five hundred seventy-six thousand, eight hundred fifty-one $(576,851)^1$ occupies ninety-seven thousand, nine hundred fourteen (97,914) square miles. Out of Wyoming's twenty-three (23) counties, four (4) counties where PATH Subrecipients provide services hold approximately forty percent (40%) of the population.

The most populous counties in Wyoming are Laramie and Natrona. Unfortunately, the previous PATH Subrecipient provider in Natrona County has chosen stop participation in the PATH Grant due to a variety of reasons, which resulted in a thirteen percent (13%) population decline from previous reports. Though the organization declined the interest of PATH funds for this year, services may continue, but will not be reported in the PATH Data Exchange System.

The first Wyoming Point in Time (PIT) count was conducted in 2014 and has continued annually. The challenges of conducting the PIT count include the very rural and frontier nature of the State, few service providers in many parts of the State, and a small number of organizations directly involved with homelessness work, including recruiting individuals and organizations within these communities to organize and conduct the count with the Wyoming Homeless Collaborative. The PATH Subrecipient Providers are expected to participate in the PIT count each year.

Due to the impacts of COVID-19 and other fiscal impacts to State of Wyoming revenue, the Behavioral Health Division (Division) has not been able to allocate State General Funds (SGFs) or Community Mental Health Block Grant funds to PATH Subrecipient providers in their respective SFY22 PATH contracts, nor will the Division plan to be able to allocate SGFs in upcoming contracts. Though, the Division has SGFs set aside to meet the Division's Intended Use Plan match requirement of the 3:1 ratio.

In FY22, the Division was granted nineteen thousand, five hundred forty-four dollars (\$19,544.00) in technical assistance funds for PATH. These funds will be used to create a manual at the Division and provider levels on the activities related to serving the PATH eligible homeless persons who are: 1) suffering from serious mental illness or suffering from serious mental illness and a substance use disorder, and 2) homeless or at imminent risk of becoming homeless.

The Division received Substance Abuse Prevention and Treatment (SAPT) Block Grants (BG) COVID-19 Relief Funds, and Wyoming has received SAMHSA approval to use the SAPT BG COVID-19 Relief Funds for targeted housing costs. Currently, one hundred thousand dollars (\$100,000.00) is allocated for assistance in covering Housing First support. Funds will be distributed between two contract periods and funding will cease March 14, 2023. Each contracted PATH Subrecipient will receive approximately sixteen thousand, six hundred sixty-six dollars and sixty-seven cents (\$16,666.67) between September 1, 2021 (or contract effective date) through August 31, 2022. In the next contracts, and based on an expectation that previous mentioned amount of funds will be spent within the first year, PATH Subrecipients will receive a minimum of six thousand six hundred sixty-six dollars and sixty-seven cents (\$6,666.67) between September 1, 2022, (or contract effective date) through March 14, 2023.

The HMIS lead agency, Institute for Community Alliance (ICA), employs a full-time equivalent HMIS Manager in Wyoming. The Behavioral Health Division (Division) receives PATH Subrecipient's monthly HMIS data from ICA. ICA is responsive to questions, requests, and provides technical assistance and support for all PATH Subrecipients. The Division provides contact information to new local-area PATH Subrecipients and ICA to establish an introduction and collaboration between the two organizations. Upon request for mediation, the Division will work with the HMIS Manager and the PATH Subrecipients.

All PATH Subrecipient providers are required, via contract, to utilize HMIS to record outreach, encounters, referrals, PATH case management, and housing placement. Providers are asked to provide semi-annual data in PDX to ensure accuracy. Several PATH providers have mentioned issues with pulling data from the HMIS to the PDX Reports, and continuously work with HMIS to address the issue(s). PATH Subrecipient providers will receive new and continued training, as requested.

Based on feedback from PATH Subrecipients, the HMIS Manager in Wyoming scheduled a mandatory training session to go over the PATH workflow. This PATH workflow training was provided on January 6, 2022 at 0900 MST and through GoToWebinar.

The Behavioral Health Division (Division) supports the statewide SSI/SSDI Outreach, Access, and Recovery (SOAR) initiative by offering the time and expertise of an internal SOAR Specialist for PATH Subrecipients.

Through Division contracts, PATH Subrecipient providers are required to have a minimum of one (1) staff person certified in the use of SOAR. SOAR-trained staff promote the use of SOAR through other community service providers to help ensure all individuals who are homeless in their community have access to this service. The use of SOAR will continue to be included as a requirement in contracts with PATH Subrecipient providers.

Paintbrush Generations has one (1) currently certified SOAR staff member. As staffing opportunities grow for this organization, it is anticipated that any future staff member will be SOAR certified.

Recover Wyoming has one (1) currently certified SOAR-LA staff member and anticipates one (1) additional staff member to be certified in SOAR. A total of two (2) certified SOAR staff.

Sweetwater Family Resource Center has one (1) currently certified SOAR staff, and anticipate two (2) staff members to be certified in SOAR. A total of three (3) certified SOAR staff.

Youth Emergency Services, Inc. has four (4) currently certified SOAR staff, and anticipate one (1) additional staff member to be certified in SOAR. A total of five (5) certified SOAR staff.

Overall, a total of eleven (11) certified SOAR staff is anticipated in regards to the PATH Grant.

Often, a potential participant is identified via outreach efforts or through the Vulnerability Index -Service Prioritization Decision Assistance Tool (or another screening tool), which can be conducted by an outreach worker, community partner, a partner in Wyoming's coordinated entry process, or PATH Subrecipient staff.

PATH eligibility is determined through a deliberate interaction between the potential participant and the PATH case manager to assess eligibility. Eligibility requires three (3) factors:

- 1. The participant must have a serious mental illness, which may include a co-occurring substance use disorder;
- 2. The participant must be literally homeless or at imminent risk of homelessness; and
- 3. The participant agrees to be a PATH participant, which does not bind the participant to any specific tasks, but does ensure that the participation is not coerced and is voluntary.

Enrollment occurs if the eligible participant agrees to participate in a PATH Subrecipient provider's services. Eligibility is documented in the Homeless Management Information System following the interactive assessment, with each interaction, and upon exiting (dis-enrolling in) services.

Charitable Choice

Dear Becky Bercier:

The Wyoming Department of Health, Behavioral Health Division (Division) is required to provide this dissemination notice of Charitable Choice to your organization, as you are a Subrecipient of a Substance Abuse and Mental Health Services Administration (SAMHSA) Grant. These funds are distributed through a current contract with the Division.

As provided by SAMHSA:

Charitable Choice provisions [under Sections 581 - 584 and Section 1955 of the Public Health Services Act, 42 U.S.C. § 290k, *et seq.*, and 42 U.S.C. § 300x-65 *et seq.*, respectively] allow religious organizations to provide SAMHSA funded substance abuse services without impairing their religious character and without diminishing the religious freedom of those who receive their services. These provisions contain important protections both for religious organizations that receive SAMHSA funding and for individuals who receive their services; and apply to religious organizations and to state and local governments that provide substance abuse prevention and treatment services under SAMHSA grants.

Under Charitable Choice provisions; Final Rule (42 CFR Part 54), states, local governments, and religious organizations, including SAMHSA grant recipients, must:

- (1) ensure religious organizations that provide services to all potential and actual program beneficiaries (services recipients) are notified of their right to alternative services;
- (2) ensure that religious organizations that provide services refer program beneficiaries to alternative services; and
- (3) fund and/or provide alternative services.

"Alternative services" means services determined by the State to be accessible and comparable and provided within a reasonable period of time by another substance abuse provider (alternative provider) to which the program beneficiary (services recipient) has no religious objection.
