The FY23 application for the [Healthy Start Initiative – Enhanced \(HSE\)](#) is now open on grants.gov. The purpose of the HSE is to improve health outcomes before, during, and after pregnancy and reduce racial/ethnic differences in rates of infant death and adverse perinatal outcomes. There is **\$11,000,000 available** for up to 10 awards.
