The Wyoming Maternal Mortality Review Committee (MMRC) report for all 2018-2020 cases is now available to the public. This report goes over the findings and contributing factors, including recommendations made by the MMRC. Funding Available

The FY23 application for the <u>Healthy Start Initiative – Enhanced (HSE)</u> is now open on grants.gov. The purpose of the HSE is to improve health outcomes before, during, and after pregnancy and reduce racial/ethnic differences in rates of infant death and adverse perinatal outcomes. There is **\$11,000,000 available** for up to 10 awards.
