Medicaid Waiver Renewals for the Care Management Entity 1915(b) & (c) Waivers

Public and Tribal notice is hereby given that the Wyoming Department of Health (WDH) intends to submit waiver renewal applications for its current 1915 (b) & (c) Care Management Entity (CME) Waivers, entitled *Wyoming Medicaid's Youth Initiative-A High Fidelity Wraparound (HFWA) Community-Based Alternative for Youth with Serious Emotional/Behavioral Challenges* with a requested effective date of July 1, 2024.

**Administration:** Will not change.

**Eligibility:** Will not change.

**Services:** Will not change.

**Payment:** Will change.

**Changes in Method and Standards:** Will not change.

**Impact to Tribal Members:** Will not change.

**Proposed Implementation Timeline:** The renewed waivers are proposed to take effect July 1, 2024.

**Fiscal Impact:** The average annualized percent proposed increase to the fee for service CME provider service reimbursement rates is 2.10% on average based on SFY22 program census plus 10% for any potential average census increases. As well as a higher utilization rate of respite services due to the proposed rate adjustment which will make this waiver's respite service reimbursement competitive with other similar waivers and state funded respite programs for similar populations.
