#### **Annual CDU 340B Recertifications**



The annual 340B recertifications period for 2024 opens May 6th and closes June 3<sup>rd</sup>. Each sub-recipient under CDUs 340B designation must meet the following criteria to be recertified each year for 340B STD and TB Office of Pharmacy Affairs Information System (OPAIS) accounts:

- OPAIS account information must be complete, accurate, and correct.
- The sub-recipient meets all 340B Program eligibility requirements.
- The sub-recipient will comply with all requirements and any accompanying regulations including, but not limited to, the prohibition against duplicate discounts and diversion
- The sub-recipients maintain auditable records (reporting) pertaining to compliance with the requirements.
- The sub-recipient acknowledges its responsibility to contact CDU as soon as possible if there is any change in 340B eligibility and/or breach by the sub-recipient.
