

- As of 2004, all pharmacy school graduates earn the PharmD degree, a doctorate degree to reflect the increased complexity of pharmacotherapy and advanced training required for adequate provision of patient care.

- Health screenings
- Point-of-care testing, with treatment allowed in some states
- Medication therapy management
- Chronic disease management
- Therapeutic drug monitoring
- All this while still ensuring medications are safe and effective for patients

# Immunizations in the Pharmacy

- Ch. 16, Sec. 4(a)
  - Pharmacists shall utilize the manufacturer's package insert for indications, contraindications, adverse reactions, dosing, route of administration, specifics regarding administration, and storage requirements for immunizations when prescribing, administering, and supervising the administration of vaccines.
- In other words, pharmacists in Wyoming can prescribe and administer all vaccines
- Pharmacy Technicians were granted administration ability in the 2022 legislative session
  - By rule must complete the same training required of a pharmacist
- Rules were last updated in August of 2023



# Record Keeping

## Keeping your records complete is like brushing every tooth; miss one, and it'll come back to bite you!

- Requirements
  - Questioner and consent form
    - Attestation of counseling
    - Advise patient to remain in the area 15 minutes
  - WY Stat § 33-24-157 (2022) Immunization administration
    - "A pharmacist administering vaccinations pursuant to this section shall enter a record of the immunization in the Wyoming immunization registry operated by the department of health"
    - Passed in 2014 all pharmacies to be compliant by 2015
- Use WYIR, it will be your best friend!




### Immunization Stats


- Pharmacists have been providing immunizations for over 20 years\*
- Majority of adult immunizations are given at a pharmacy
- Post 2020 pharmacies have seen a major increase in vaccine administration
- Pharmacies are increasing immunization rates of atypical vaccines
  - HPV
  - Shingles
  - RSV?

# Highlights of Immunization Schedule Changes

#### COVID-19

- Pemgarda™ a monoclonal antibody immunization approved for use in pre-exposure prophylaxis for moderate to severely immunocompromised
- Guidance provided on using updated vaccines, bivalent were removed from all recommendations

#### Influenza

 Persons with any severity of egg allergy can be vaccinated with any type of flu vaccine

#### Pneumonia

- PCV13 has been removed from all recommendations
- "Special situations" have all been updated to reflect use of PCV15, PCV20, and PPSV23



# Highlights of Immunization Schedule Changes

- Respiratory Syncytial Virus (RSV)
  - Note added for administration in 60 and older and pregnant women from weeks 32-36 during September – January
  - Added guidance on administration of nirsevimab in infants six months and older
  - RSV vaccine added to the list of vaccines excluded from the Vaccine Injury Compensation Program (VCIP)
- Human Papilloma Virus (HPV)
  - Guidance was added for immunizing those 26-45 (22-23 clarification)
  - Clarification was provided on catch up doses
- DTaP/Tdap
  - Clarification was provided on primary and booster doses adding Tdap as booster for primary series



# Highlights of Immunization Schedule Changes

#### Polio

 "Catch up" has been revised to include 18 year old individuals with special risk factors

### Meningococcal

Menactra has been removed from all sections and been replaced with Penbraya<sup>TM</sup> or a combination of Menveo® and Bexsero®

### Mpox

- Guidance added for use in adolescents at age 18 based on risk factors
- Mpox vaccine added to the list of vaccines excluded from the Vaccine Injury Compensation Program (VCIP)
- Mpox vaccine added to the list of vaccines covered by the Countermeasures Injury Compensation Program (CICP)



# PREP Act for Pharmacy

- Allowed pharmacists and pharmacy technicians under the supervision of a pharmacist to administer without a prescriber order
  - COVID-19 vaccines for all individuals who are 3 years of age and older
  - All Advisory Committee on Immunization Practices-recommended(ACIP) pediatric vaccines to those between 3 and 18 years
  - Flu vaccines for all patients 18 years and older
- Allowed pharmacists to order and administer COVID 19 test
- Allowed pharmacists to prescribe COVID antivirals
- Allowed pharmacists to therapeutically adjust medications when a COVID antiviral has been prescribed



# Expiration of PREP Act

- Scheduled to end October 1, 2024
- What does that mean for Wyoming?
  - Pharmacists will no longer have test to treat privileges and will need a collaborative practice agreement or providers order
  - Pharmacist will not have the ability to therapeutically adjust medication for COVID antivirals
  - Can only administer immunizations to those 7 years and above
- Good news!
  - Pharmacy technicians were statutorily given the ability to immunize in Wyoming in 2022

# Advocating for Wyoming Patients

- How to prevent the loss of care?
  - Encourage Wyoming law makers to take the steps needed to allow pharmacists to engage in test-to-treat practice
  - Work with your local pharmacies to start a collaborative practice agreement allowing test-to-treat
  - Support Federal Legislation:
    - **H.R.1770 Equitable Community Access to Pharmacist Services Act.** Allows pharmacist to continue PREP Act COVID measures for all respiratory viruses for Medicare eligible patients. Currently has 160 cosponsors
    - **S.2477 Equitable Community Access to Pharmacist Services Act.** Mirror bill in the Senate increasing chances of the topic being heard. Currently has 24 cosponsors
    - Must be heard before the end of the year. Last action on either bill was in 2023
