

Standardization: Creating an Appointment

Standardization of information collected and method of entry

- 1. Legal Name (preferred)
- 2. DOB
- 3. Vaccine requested
- 4. Insurance Carrier
- 5. \$\$ expected to collect
- 6. Telephone Number

Review WyIR record to determine eligibility of vaccine requested

Examples: *Run Transact; John Smith; 04/24/41; Shingrix; MDCR D Humana; 0\$; 307-555-5555

Anna Jones; 08/17/1986; Tdap; BCBS; 0\$; 307-461-5869

Jason Anderson; 12/21/2000; HPV; VUA; 20\$; 307-512-5412



Standardization: Intake Procedures

Standard intake packet for every immunization client:

- 1. Routing Slip
- 2. Screening Form
- 3. VIS Form for vaccine appt
- 4. Copy of insurance card

Possible Additions:

- 1. Transact RX
- 2. Other insurance information
- 3. VIS for recommendations of other vaccines they may be eligible for
- 4. Vouchers for agency billing
- 5. ROI
- 6. Language support as needed

- Prepare packets day before
- Reminder calls
- RN evaluates other vaccine recs prior to appt

Interview & Administer

Assess whether patients are ready

- Listen to concerns
- Educate regarding risks and benefits of each vaccine— Everything is a teachable moment
- Address fear, hesitancy, myths

Methods for administering to fearful patients of all ages

- Ask them "What helps?"
- Cede Control
- Distraction
- Food
- Environment

WyIR Entry- Verify-Change-Merge

- Demographics
- Historical Vaccine Records
- Multiples?
- Need records printed?
- ROI for college/ employer requests




