

Psychiatric Residential Treatment Placement Information

A Psychiatric Residential Treatment Facility (PRTF) is a 24-hour, supervised, inpatient level of care provided to children and adolescents up to age 21 who have long-term mental health or psychiatric illnesses and/or serious emotional disturbance(s) that are not likely to respond to short term interventions and have failed to respond to community-based intervention(s).

PRTFs provide comprehensive mental health and substance abuse treatment service to children and adolescents who need quality, proactive treatment. PRTFs also provide instruction and support toward attainment of developmentally appropriate basic living skills/daily living activities that will enable children and adolescents to live in the community upon discharge. The focus of a PRTF is on the improvement of a member's symptoms through the use of evidence based and appropriate interventions such as group and individual therapy, behavior management, medication management, and active family engagement, including family therapy.



PRTF Placement Process*

Please Note: WYhealth will reach out to discuss the placement process and share the PRTFs that are enrolled with Wyoming Medicaid; however, contacting the PRTFs to share and describe the member and their behaviors to PRTF admissions (i.e.: including filling out PRTF applications, verbally sharing protected health information (PHI) with the facility, and providing medical records with the facility (if requested) throughout the placement process), is at the discretion and direction of the member's parent or legal guardian. WYhealth will assist by providing a list of actively enrolled PRTFs to the parent/guardian. **PRTF placement is not guaranteed - a PRTF may deny the youth from admitting if the child is determined not to be a good fit.**

1. **(Us) Wyoming Medicaid** - Sends PRTF placement information to the Parent/Guardian, including enrolled PRTFs, and contact information to support the parent/guardian to find placement for the youth.
2. **(You) Parent/Guardian** - You will contact the Admissions Department at the enrolled PRTFs (listed on next pages). The Admissions Department will ask you questions about the youth, typically about their behavior and medical diagnoses.
3. **PRTF** - Once you've contacted the Admissions Department at each PRTF, they will review the information you've provided and will make a determination on whether placement at their facility will be appropriate for your youth. There are a couple of possible outcomes -
 - Approval (the youth is accepted for admission to the PRTF and has an admission date),
 - Approval, but waitlisted (the youth is accepted for admission to the PRTF and is waitlisted until there is space available),
 - Denial (the PRTF has determined the youth is not a good fit for their program),
 - Pending (PRTF still reviewing placement and has not made a final determination - if this is the case, keep following up!)

Things to Keep in Mind

- **A psychiatric evaluation** must be completed by a board eligible or board certified child and adolescent psychiatrist within 45 days of admission to a PRTF which includes a recommendation for PRTF placement (if you do not have one, please have the youth's behavioral health provider contact WYhealth about setting up a consultation and PRTF evaluation (billed to Wyoming Medicaid) - the provider can call or email WYhealth at:

- **PRTF Referral Networks.** Kidlink Treatment Services and Acadia/Children's Behavioral Solutions Services both have a PRTF referral network and streamlined process for submitting requests to PRTFs in some cases - these are another mechanism for identifying a placement opportunity for your youth. - **Transportation.** Upon approval for PRTF, transportation for the youth and one guardian to and from the facility may be arranged depending on your distance to the PRTF.
