

Wyoming Statewide Share of Opioid Funds (SSOF) Report

January 2026

As the lead agency for the Statewide Share of Opioid Funds (SSOF) received as part of the OneWyo Opioid Settlement Memorandum of Agreement, the Wyoming Department of Health is required to publish a public report on the following:

- The amount of funds received;
- The amount of funds expended, broken down by strategy, program, or project; and
- The amount of any grants awarded, listing the recipients, amounts awarded, amounts disbursed, and disbursement terms, programs, strategies, and projects funded.

As of January 9, 2026, the Wyoming Department of Health has received \$10,751,934.

Table 1 summarizes the amounts allocated by project for the Behavioral Health Division. Table 2 summarizes the amounts allocated by project for the Public Health Division. Table 3 provides a list of completed SSOF-funded projects for the Public Health Division.

Contractor is the Wyoming Association of Sheriffs and Chiefs of Police for the administration of the grant program for detention centers.
Alternatives to Pain Management Assessment/ Toolkit	\$150,000	\$130,000	\$20,000	Contract for a summary report of healthcare provider and health system opioid abuse/misuse prevention best practices, alternative therapies, training, and toolkit development. Through a competitive bid process, Comagine Health has initiated work.
Plans of Safe Care (POSC)	\$1,737,947	\$614,298	\$713,563	Service providers involved in POSC will use a cross-agency collaborative Children and Recovering Mothers (CHARM) model to coordinate care for pregnant and postpartum mothers with a history of opioid use disorder and their affected infants. County contracts will ensure staffing, where capacity is limited, to provide home visiting to POSC participants and participation in the cross-agency collaborative. Contracts are in place with Casper Natrona County Health

				Department and Cheyenne Laramie County Health Department to support staffing, and Western States Learning Corporation for the facilitation of CHARM collaboratives. Other county support will be provided through state personnel expenses.
Distribution of Naloxone	\$309,152	\$153,736	\$155,416	Contract with Truax Patient Services, LLC for the distribution of NARCAN ® 4 mg nasal spray to agencies, businesses, and organizations in Wyoming.
Public Education Campaign	\$685,000	\$495,673	\$189,327	Contract for educational media and website focusing on opioid prevention for a broad audience. Through a competitive bid process, Sukle Advertising & Design has initiated work.
University of Wyoming Project	\$121,509	\$0	\$0	Agreement with the University of Wyoming, College of Health Sciences, Division of Kinesiology and Health, to examine pain and opioid related knowledge and behaviors among student-athletes and athletic trainers.

Project Name	Expended	Description
Workforce Safety Video Support	\$100,000	Contract with Warehouse 21 for an opioid prevention training video and resources for workplaces located at letstalkwy.org . The project was completed.
Qualitative Opioid Use Project	\$24,375	Qualitative data from persons with lived experience were collected and analyzed to inform decision-making on how best to decrease the abuse/misuse of opioids. The project was completed through a contract with Recover Wyoming.
Workforce Educational Materials and Expansion of Naloxone	\$39,273	Contract for workforce educational materials for workplace organizations to provide to employees/contractors who are transitioning out of employment and are at increased risk of overdose, and the expansion of access to naloxone. The project was completed through a contract with The Naloxone Project.
Workforce Assessment/ Toolkit	\$128,118	Contract with TriWest Group, LLC for a report of workforce best practices and the development of a toolkit to provide employers with resources for promoting a culture of health and safety in the workplace to prevent overdose deaths.
