

Comprehensive and Supports Waivers Amendment Summary

The Division of Healthcare Financing (DHCF), Home and Community-Based Services (HCBS) Section intends to seek approval from the Centers for Medicare and Medicaid Services (CMS) to amend the Comprehensive and Supports Waivers Program. The purpose of this amendment is to incorporate additional funding passed by the 2026 Wyoming State Legislature for the Comprehensive and Supports Waivers to decrease the Supports Waiver Waitlist and increase provider rates first restoring rates that were previously funded by ARPA. The proposed effective date for the Waiver renewal is July 1, 2026. A summary of proposed changes are listed below:

 - B-3-a - Updated the Total Unduplicated Number of Participants.
 - B-3-b- Updated the Total Maximum Number of Participants Served At Any Point During the Year.
- Appendix C:
 - C1/C3
 - **Case Management:**
 - Updated the Case Management Service Definition Monthly Unit. The language states, “A monthly case management visit to the participant’s residence is required. The participant must be present to monitor their health and welfare, discuss service satisfaction, and identify any necessary IPC changes.”
 - Removed the language on Quarterly Visits in the Case Management Service Definition under the 15 Minute Unit.
 - Updated the Case Management Service Definition 15 Minute Unit. The language states, “Monthly visits to the participant’s place of residence are required. The participant must be present during the visit.”
 - C-4-a
 - (Supports Waiver Only) Updated budget limits for adults and children on the waiver.
- Appendix I:
 - I-2-a - Updated rate methodology descriptions for increase in provider rates and ARPA rates reinstatement.
- Appendix J:
 - J-2-a - Updated Table: Unduplicated Participants for Waiver Years 3, 4 and 5.
 - J-2-c-i - Updated the text to align with the new Factor D Derivation estimates.
 - J-2-d-i - Updated the tables for Waiver Years 3-5 to align with the new number of users and average units per user.
